BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows: 18 **Article - Transportation** 19 21-1205. 20 Each person operating a bicycle or a motor scooter AT A SPEED LESS THAN (a) 21 THE NORMAL SPEED OF TRAFFIC on a roadway shall ride as near to the right side of 22 the roadway as practicable and safe, except when [making]: 23 MAKING or attempting to make a left turn[, when operating]; (1) 24 (2) OPERATING on a one-way street[, or when passing];

PASSING a stopped or slower moving vehicle;

AVOIDING PEDESTRIANS OR ROAD HAZARDS;

- 1 (5) APPROACHING A LOCATION WHERE A RIGHT TURN IS AUTHORIZED; 2 OR
- 3 (6) OPERATING IN A LANE THAT IS TOO NARROW FOR A BICYCLE OR 4 MOTOR SCOOTER AND A VEHICLE TO TRAVEL SAFELY SIDE BY SIDE WITHIN THE
- 5 LANE.
- 6 (b) Each person operating a bicycle or a motor scooter on a roadway may ride 7 two abreast only if the flow of traffic is unimpeded.
- 8 (c) Each person operating a bicycle or a motor scooter on a roadway shall 9 exercise due care when passing a vehicle.
- 10 (d) Each person operating a bicycle or a motor scooter on a roadway may walk 11 the bicycle or motor scooter on the right side of a highway if there is no sidewalk.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 October 1, 2004.
