FISCAL AND POLICY NOTE

House Bill 1065 Ways and Means

(Delegate Fulton)

Baltimore City - Board of School Commissioners

This bill alters the appointment of voting members of the Baltimore City Board of School Commissioners so that the proportion of voting members appointed by the Mayor of Baltimore reflects the proportion of Baltimore City's financial contribution towards total funding for the school system in a specified fiscal year. The bill requires that when a vacancy occurs on the board, the Maryland State Board of Education must make a determination as to the percentage of Baltimore City fund contribution for the specified fiscal year.

The bill takes effect July 1, 2004.

Fiscal Summary

State Effect: None.

Local Effect: None. The bill would not affect Baltimore City finances.

Small Business Effect: None.

Analysis

Current Law: The Baltimore City Board of School Commissioners consists of 10 members – nine voting members appointed jointly by the Governor and Mayor of Baltimore and one student member. Voting members serve for three years, and are not entitled to compensation. Student members serve for one year.

Background: The selection methods and number of school board members for the 24 local boards of education are shown in **Exhibit 1**.

Local Fiscal Effect: Funding for the Baltimore City Public School System totals approximately \$975 million in fiscal 2004. Of this amount, \$625 million or 64% is State funds, \$207 million or 21% is city funds, and \$143 million or 15% is federal funds. Pursuant to this legislation, the Governor would appoint seven members of the school board and the Mayor would appoint two members.
