AMENDMENT NO. 1

On page 1 of the bill, strike beginning with "requiring" in line 10 down through "exercises" in line 12 and substitute "establishing the duties of the Task Force".

In the Education, Health, and Environmental Affairs Committee Amendments (SB0440/654337/1), in line 2 of Amendment No.1, strike "authorizing the Task Force".

AMENDMENT NO. 2

On page 1 of the bill, in line 21, after "(b)" insert "(1)"; and in lines 22, 24, and 26, strike "(1)", "(2)", and "(3)", respectively, and substitute "(i)", "(ii)", and "(iii)", respectively.

On page 2 of the bill, in line 1, strike "(4)" and substitute "(iv) the Chancellor of the University System of Maryland, or the Chancellor's designee;

<u>(v)</u>";

in lines 3 and 4, strike "(5)" and "(i)", respectively, and substitute "(vi)" and "1.", respectively; and before line 10, insert:

"(2) The members of the Task Force shall be residents of the State.".

In the Education, Health, and Environmental Affairs Committee Amendments, in lines 3, 5, 9, and 12 of Amendment No. 2, strike "(ii)", "1.", "2.", and "3.", respectively, and substitute "2.", "A.", "B.", and "C.", respectively.

On page 2 of the bill, in line 16, after "(f)" insert "(1)"; strike beginning with the colon in line

16 down through "(1)" in line 17; and strike beginning with "; and" in line 21 down through "tolerance" in line 26; and after line 26, insert:

"(2) The Task Force may examine:

- (i) current course offerings on the subjects of the Holocaust, genocide, human rights, and tolerance at constituent institutions of the University System of Maryland;
- (ii) academic approaches taken in other states for the effective teaching of the Holocaust, genocide, human rights, and tolerance;
- (iii) national best practices regarding training activities and exercises for public school teachers to effectively teach about the Holocaust, genocide, human rights, and tolerance; and
- (iv) possible sources of funds to establish and sustain a Center for Excellence on the Study of the Holocaust, Genocide, Human Rights, and Tolerance.
- (3) The Task Force may not make recommendations regarding mandatory course content or curricular materials for the University System of Maryland or public schools.".

In the Education, Health, and Environmental Affairs Committee Amendments, in line 14 of Amendment No. 2, strike "may".
