AMENDMENTS TO SENATE BILL NO. 660

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "Senator Astle" and substitute "Senators Astle and Exum"; in line 16, after "met;" insert "providing that a mortgage lender is not required to maintain an office in the State if the laws of the state in which its principal office is located authorize a mortgage lender from this State to engage in mortgage lending without maintaining an office in that state;"; in line 22, strike "provisional denial,"; and in line 24, strike "a license" and substitute "an investigation".

AMENDMENT NO. 2

On page 2, in line 35, after "(D)" insert "<u>'INDEPENDENT CONTRACTOR" MEANS A PERSON WHOSE COMPENSATION IS PAID WITHOUT A DEDUCTION FOR FEDERAL OR STATE INCOME TAX.</u>

(E)".

On page 3, in lines 1, 3, 5, 7, 9, and 10, strike "(E)", "(F)", "(G)", "(H)", "(I)", and "(J)", respectively, and substitute "(F)", "(G)", "(H)", "(I)", "(I)" and "(K)", respectively; in line 15, strike "AND"; in line 26, strike "(V)" and substitute "(IV)"; in line 30, after "LENDER;" insert "OR"; in line 31, strike "; OR" and substitute a period; and strike in their entirety lines 32 through 34, inclusive.

On page 4, strike in their entirety lines 1 through 3, inclusive; in line 4, strike "(K)" and substitute "(L)"; and after line 23, insert:

"(A) (1) THE LICENSING PROVISIONS OF THIS SUBTITLE DO NOT APPLY TO INDEPENDENT CONTRACTORS.

(2) <u>INDEPENDENT CONTRACTORS ARE SUBJECT TO THE LICENSING PROVISIONS OF SUBTITLE 5 OF THIS TITLE UNLESS EXEMPT FROM LICENSING UNDER</u> § 11-502 OF THIS TITLE.

On page 5, in line 2, after "IN" insert "WRITING IN".

AMENDMENT NO. 3

On page 5, in line 8, after "INDIVIDUAL" insert "WHO IS"; in line 9, strike "THE" and substitute "THAT HAS ITS"; in the same line, strike "OF WHICH IS"; after line 13, insert:

"(E) NOTWITHSTANDING PARAGRAPH (D)(2) OF THIS SECTION, A MORTGAGE LENDER IS NOT REQUIRED TO MAINTAIN AN OFFICE IN THIS STATE IF THE LAWS OF THE STATE IN WHICH ITS PRINCIPAL OFFICE IS LOCATED AUTHORIZE A MORTGAGE LENDER FROM THIS STATE TO ENGAGE IN MORTGAGE LENDING WITHOUT MAINTAINING AN OFFICE IN THAT STATE.";

in line 25, strike "THE" and substitute "<u>ANY</u>"; strike beginning with "UNDER" in line 26 down through "SUBTITLE" in line 27; and in line 29, strike "CONDUCTED IN THE STATE".

On page 6, in line 24, strike "DISCLOSING" and substitute "BY".

On page 7, in line 2, strike "REGULATOR" and substitute "<u>REGULATORY</u>"; in line 6, strike "APPLICATION" and substitute "<u>INVESTIGATION</u>"; and in lines 27 and 28, strike "OR PROVISIONALLY DENIED".

On page 9, in line 13, strike "A LICENSE" and substitute "<u>LICENSES</u>"; and in line 19, strike "INDIVIDUALS" and substitute "PERSONS".

On page 10, in line 12, after "LENDING" insert "<u>UNDER SUBTITLE 5 OF THIS TITLE</u>"; and in line 25, strike "A" and substitute "ANY OTHER".

On page 14, in lines 24 and 25, in each instance, after "SUBTITLE" insert "OR UNDER SUBTITLE 5 OF THIS TITLE".
