AMENDMENTS TO HOUSE BILL NO. 651 (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Rudolph" and substitute "<u>Rudolph, Bromwell,</u> <u>Donoghue, Elliott, Frank, Mandel, McDonough, Morhaim, Murray, Nathan-Pulliam, Oaks, V.</u> <u>Turner, and Weldon</u>".

AMENDMENT NO. 2

On page 2, after line 16, insert:

"(I) <u>THE PROCEDURES AND TIMELINES THAT PROVIDERS MUST</u> FOLLOW WHEN REPORTING SERIOUS REPORTABLE INCIDENTS AND DEATHS TO THE ADMINISTRATION AND THE OFFICE OF HEALTH CARE QUALITY;";

in lines 17, 19, 21, 23, and 26, strike "(I)", "(II)", "(III)", "(IV)", and "(V)", respectively, and substitute "<u>(II)</u>", "<u>(III)</u>", "<u>(IV)</u>", "<u>(V)</u>", and "<u>(VI)</u>", respectively; strike beginning with "THE" in line 17 down through "DEATHS;" in line 18 and substitute "<u>THE DEPARTMENT'S PROTOCOL TO DETERMINE THE NECESSITY TO INVESTIGATE A SERIOUS REPORTABLE INCIDENT THAT TAKES INTO ACCOUNT:</u>

<u>1.</u> <u>THE SEVERITY OF THE INCIDENT;</u>

2. <u>THE QUALITY OF THE LICENSEE'S INTERNAL</u> INVESTIGATION; AND

<u>3.</u> <u>THE NUMBER AND FREQUENCY OF SERIOUS</u> <u>REPORTABLE INCIDENTS REPORTED BY THE LICENSEE TO THE DEPARTMENT;</u>";

in line 20, strike "INVESTIGATING LICENSEES" and substitute "ANY FOLLOW-UP

(Over)

INVESTIGATIONS THAT MAY OCCUR DUE TO A LICENSEE'S REPORT OF A SERIOUS REPORTABLE INCIDENT OR DEATH"; and in line 30, after "OTHERS;", insert "AND".

On pages 2 and 3, strike in their entirety the lines beginning with line 31 on page 2 through line 5 on page 3, inclusive, and substitute:

"(VII) FOLLOW-UP PROTOCOLS FOR THE OFFICE OF HEALTH CARE QUALITY AND THE ADMINISTRATION TO ENSURE THAT CORRECTIVE ACTION HAS BEEN IMPLEMENTED BY THE LICENSEE.".
