AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Vaughn" and substitute "<u>Vaughn, Burns, Conroy,</u> <u>Doory, Harrison, Kirk, Krysiak, McHale, and Parrott</u>".

AMENDMENT NO. 2

On page 1, in line 3, strike "immigration consultants" and substitute "<u>certain persons</u>"; in lines 4 and 13, in each instance, strike "foreign nationals" and substitute "<u>noncitizens and persons</u> <u>seeking to sponsor a noncitizen</u>"; strike beginning with "establishing" in line 5 down through "presumption;" in line 6; strike beginning with "establishing" in line 8 down through "Act" in line 9 and substitute "<u>providing that an immigration consultant that violates this Act is guilty of a misdemeanor; establishing certain criminal penalties for a violation of this Act"; and strike beginning with "in" in line 11 down through "damages" in line 12.</u>

AMENDMENT NO. 3

On page 2, in line 1, strike "OR ENTITY"; in line 7, after "MATTER" insert "<u>FOR A FEE</u>"; in line 8, after "ANY" insert "<u>LEGAL</u>"; in line 12, after "(I)" insert "<u>ANY</u>"; in lines 15, 16, and 17, in each instance, strike "U.S." and substitute "<u>UNITED STATES</u>"; in line 21, strike "OR" and substitute "<u>FORMS ON BEHALF OF AN INDIVIDUAL</u>,"; in the same line, strike "FOR" and substitute "<u>ON BEHALF OF</u>"; in line 25, strike "AND" and substitute "<u>OR</u>"; in line 30, strike "CLIENTS" and substitute "<u>INDIVIDUALS</u>"; in lines 31 and 34, in each instance, strike "THE CODE OF FEDERAL REGULATIONS, TITLE 8," and substitute "<u>8 CFR</u>"; in line 32, strike "OR"; in line 33, strike "ACCREDITED" and substitute "<u>RECOGNIZED</u>"; and strike beginning with the third comma in line 34 down through "OR" in line 35 and substitute a semicolon.

On page 3, in line 1, strike "AN ACCREDITED" and substitute "<u>A</u>"; strike beginning with "WHO" in line 2 down through "ACCREDITED" in line 3 and substitute "<u>THAT HAS BEEN</u> <u>RECOGNIZED</u>"; strike beginning with "THE" in line 3 down through the comma in line 4 and

substitute "<u>8 CFR</u>"; strike beginning with "(II)" in line 5 down through "2006" in line 6 and substitute:

"(5) <u>A CLINIC AFFILIATED WITH A LAW SCHOOL IN THE STATE</u>";

in line 8, strike "(A)"; in line 9, strike "GIVE ANY LEGAL ADVICE OR"; in the same line, after the second "LEGAL" insert "<u>ADVICE OR LEGAL</u>"; in line 10, after "CONCERNING" insert "<u>AN</u>"; in the same line, strike "MATTERS" and substitute "<u>MATTER</u>"; in lines 15, 16, and 17, in each instance, strike "U.S." and substitute "<u>UNITED STATES</u>"; in line 25, strike "GIVE LEGAL ADVICE OR"; and in line 26, after "LEGAL" insert "<u>ADVICE OR LEGAL</u>".

On page 4, in line 6, strike "GIVE" and substitute "<u>PROVIDE</u>"; in lines 8 and 11, in each instance, after "CONTRACT" insert "<u>IN AT LEAST 12 POINT TYPE</u>"; in line 8, after the semicolon insert "<u>AND</u>"; strike beginning with the semicolon in line 11 down through "ATTORNEY" in line 14; in line 15, strike "BOTH"; in lines 15 and 16, strike "THE CLIENT'S NATIVE LANGUAGE" and substitute "<u>IN EACH LANGUAGE IN WHICH THE IMMIGRATION</u> <u>CONSULTANT PROVIDES SERVICES</u>"; and in line 27, strike "GIVE" and substitute "<u>PROVIDE</u>".

AMENDMENT NO. 4

On page 3, strike in their entirety lines 27 through 29, inclusive.

On page 5, strike beginning with "IN" in line 3 down through "SECTION" in line 11.
