AMENDMENTS TO HOUSE BILL NO. 1341

(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with “authorizing” in line 8 down through “Initiative;” in line 10; in line 12, strike “on and consult” and substitute “and to consult with the Department”; in the same line, strike “from certain programs or entities”; in line 14, strike the second “certain” and substitute “the”; in line 15, strike “and determining” and substitute “the appropriateness of”; in line 16, after “cases” insert “and determining how certain data may be preserved”; in line 18, after “report” insert “to the General Assembly”; in line 19, strike “to the General Assembly”; in the same line, strike “on data collected”; in the same line, after “and” insert “the”; in lines 20 and 21, in each instance, strike “a”; in line 21, strike “appropriation” and substitute “appropriations”; in the same line, strike “year” and substitute “years”; strike beginning with “requiring” in line 21 down through “amount” in line 23; in line 24, strike “transaction” and substitute “transactions”; and in the same line, strike “authorizing” and substitute “requiring”.

On page 2, in line 1, strike “if the child is”; in the same line, after “brought” insert “to the providers”; in line 3, after “circumstances;” insert “defining certain terms;”; in line 4, after the first “Secretary” insert “of Health and Mental Hygiene”; in line 5, after “Resources” insert a comma; in line 6, strike “representatives” and substitute “members”; in the same line, strike “investigate” and substitute “study and make recommendations on”; in lines 9 and 10, strike “regarding certain recommendations” and substitute “; and generally relating to the establishment of a Child Abuse and Neglect Centers of Excellence Initiative”; and in line 13, strike “13-2107” and substitute “13-2106”.

AMENDMENT NO. 2

On page 2, strike beginning with “WHO” in line 34 down through “INSTITUTES” in line 36 and substitute “AS DESIGNATED BY THE DEPARTMENT”.

On page 3, in line 12, strike “PURPOSE” and substitute “PURPOSES”; and in the same line, strike “IS” and substitute “ARE”.

(Over)

On pages 3 and 4, strike beginning with “TO” in line 31 on page 3 down through “13-2104.” in line 1 on page 4.

On page 4, in lines 16 and 24, strike “13-2105.” and “13-2106.”, respectively, and substitute “13-2104.” and “13-2105.”, respectively; in line 18, strike the first “ON”; in the same line, after “CONSULT” insert “WITH THE DEPARTMENT”; in the same line, strike “FROM”; in line 19, after “(1)” insert “REFERRED FROM”; in lines 20 and 22, in each instance, before the first “A” insert “CONCERNING”; in line 34, after “STATE” insert a comma; and in the same line, strike “BY CREATING” and substitute “THROUGH THE CREATION OF”.

On page 5, in line 2, strike “EVERY” and substitute “EACH”; in line 3, strike “OTHER FACILITIES PROVIDING” and substitute “ANY OTHER FACILITY THAT PROVIDES”; in line 6, after “(D)” insert “ON OR BEFORE DECEMBER 1 OF EACH YEAR,”; strike beginning with “ON” in line 6 down through “YEAR” in line 7; and in line 9, after “DIAGNOSIS” insert “AND”.

On page 7, in line 31, after “(4)” insert “a”; and in line 34, strike “especially” and substitute “including”.

On page 8, in line 1, after “workgroup” insert “:

(1)”;

in the same line, strike “investigate” and substitute “study”; in line 3, strike “a”; in the same line, strike “investigation” and substitute “investigations”; in the same line, strike the period and substitute “; and

(2) on or before December 1, 2005, shall report its findings and recommendations, in”;

strike line 4 in its entirety; and strike beginning with “regarding” in line 6 down through “investigation” in line 7.

### AMENDMENT NO. 3

On page 5, in line 10, strike “13-2107.” and substitute “13-2106.”; and in line 14, strike “2007” and substitute “2008”.
