"BY repealing

AMENDMENT NO. 2

On page 2, in line 5, strike the bracket; and in the same line, strike "13" and substitute "12".

On pages 2 and 3, strike in their entirety the lines beginning with line 7 on page 2 through line 3 on page 3 and substitute:

- "(3) [Subject to the approval of the Board, the Chief Executive Officer shall appoint the 13 members of the Advisory Board as follows] THE ADVISORY BOARD CONSISTS OF THE FOLLOWING MEMBERS:
- (I) ONE REPRESENTATIVE OF THE PRINCE GEORGE'S COUNTY SENATE DELEGATION;
- (II) ONE REPRESENTATIVE OF THE PRINCE GEORGE'S COUNTY HOUSE DELEGATION;

- (III) ONE REPRESENTATIVE OF THE COUNTY EXECUTIVE OF PRINCE GEORGE'S COUNTY;
- (IV) ONE REPRESENTATIVE OF THE COUNTY COUNCIL OF PRINCE GEORGE'S COUNTY; AND
- (V) THE FOLLOWING MEMBERS, WHO SHALL BE APPOINTED BY THE COUNTY EXECUTIVE OF PRINCE GEORGE'S COUNTY WITH THE ADVICE AND CONSENT OF THE COUNTY COUNCIL OF PRINCE GEORGE'S COUNTY:
- [(i)] 1. [Five shall be appointed] TWO REPRESENTATIVES from a list submitted by the Prince George's County Council of Parent-Teacher Associations;
- [(ii)] 2. [Two shall be appointed] ONE REPRESENTATIVE from a list submitted by the [Committee of 100] PRINCE GEORGE'S COUNTY TALENTED AND GIFTED;
- [(iii) Three shall be appointed from a list submitted by the Title I liaisons; and
- (iv)] 3. [Three shall be appointed] ONE REPRESENTATIVE from a list submitted by [other parent and community groups in Prince George's County] THE NAACP, PRINCE GEORGE'S CHAPTER;
- 4. ONE REPRESENTATIVE OF THE PRINCE GEORGE'S COUNTY CHAMBER OF COMMERCE;
- 5. ONE REPRESENTATIVE FROM A LIST SUBMITTED BY THE ARC OF PRINCE GEORGE'S COUNTY;
 - 6. ONE TITLE I PARENT; AND
- 7. ONE REPRESENTATIVE OF THE PRINCE GEORGE'S COUNTY MUNICIPAL ASSOCIATION.".

AMENDMENT NO. 3

On page 3, in line 23, strike "REPLACED" and substitute "<u>REMOVED AND REPLACED BY THE APPROPRIATE APPOINTING AUTHORITY</u>"; and in lines 26 and 29, in each instance after "BOARD" insert "<u>, THROUGH THE PRINCE GEORGE'S COUNTY PUBLIC SCHOOL SYSTEM STAFF ASSIGNED TO IT</u>,".

AMENDMENT NO. 4

On page 3, in line 32, after "That" insert "Section(s) 4-406 of Article - Education of the Annotated Code of Maryland be repealed.

SECTION 3. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take effect on the date that an elected Board of Education for Prince George's County takes office.

SECTION 4. AND BE IT FURTHER ENACTED, That, except as provided in Section 3 of this Act,".
