- (2) ANY SURPLUS MONEYS REMAINING AFTER THE ADMINISTRATION HAS RECOVERED THE COSTS OF ISSUING SPECIAL REGISTRATION PLATES UNDER THIS SECTION SHALL BE DISBURSED BY THE ADMINISTRATION TO THE TRANSPORTATION TRUST FUND.
- (3) NO PORTION OF THE FEE COLLECTED UNDER THIS SECTION MAY BE CREDITED TO THE GASOLINE AND MOTOR VEHICLE REVENUE ACCOUNT FOR DISTRIBUTION UNDER § 8-403 OR § 8-404 OF THIS ARTICLE.".
