AMENDMENTS TO HOUSE BILL NO. 976

(First Reading File Bill)

AMENDMENT NO. 1

On page 2, in line 23, strike "on terms that the court considers appropriate,".

On page 3, in line 20, after "(E)" insert "(<u>1</u>)"; in lines 22, 24, 26, 30, 31, 32, 33, and 34, strike "(1)", "(2)", "(3) (I)", "(II)", "1.", "2.", "3.", and "4.", respectively, and substitute "(<u>I</u>)", "(<u>III</u>)", "(<u>III</u>)", "(<u>III</u>)", "(<u>III</u>)", "(<u>III</u>)", and "(<u>IV</u>)", respectively; and in line 30, after "REPORT" insert "UNDER PARAGRAPH (1)(III) OF THIS SUBSECTION".

On page 4, in lines 1, 5, 7, 9, 11, 13, and 15, strike "(III)", "1.", "2.", "3.", "(IV)", "1.", and "2.", respectively, and substitute "(3)", "(II)", "(III)", "(4)", "(II)", "(III)", and "(III)", respectively; in line 2, strike "SUBPARAGRAPH (II)" and substitute "PARAGRAPH (1)(III)"; in the same line, strike "PARAGRAPH" and substitute "SUBSECTION"; in line 11, strike "(III)" and substitute "(3)"; and in line 19, strike "(E)(3)" and substitute "(E)(1)(IIII)".

AMENDMENT NO. 2

On page 4, in line 30, strike "Guardianship" and substitute "<u>CUSTODY AND</u> GUARDIANSHIP".

On page 5, in line 29, after the second "A" insert "CUSTODY AND".

AMENDMENT NO. 3

On page 6, in line 8, after the third "the" insert "<u>LOCAL</u>"; in lines 10 and 11, in each instance, strike the brackets; in line 10, strike "OR"; in line 20, strike the semicolon and substitute "THAT:

1. <u>ADDRESSES THE INDIVIDUALIZED NEEDS OF THE</u>
CHILD, INCLUDING THE CHILD'S EDUCATIONAL PLAN, EMOTIONAL STABILITY,

PHYSICAL PLACEMENT, AND SOCIALIZATION NEEDS; AND
