EHE

- (a) A license issued under this subtitle is the property of the State and only is loaned to a licensee.
- (b) Each licensee shall display [his] THE LICENSEE'S license conspicuously on the premises where a riding stable is operated by the licensee.
- (c) (1) <u>EACH LICENSEE SHALL DISPLAY THE LICENSEE'S LICENSE NUMBER ON A SIGN POSTED ON THE PREMISES WHERE A RIDING STABLE IS OPERATED BY THE LICENSEE.</u>
- (2) THE SIGN SHALL BE POSTED AT A HEIGHT AND IN A POSITION THAT CAN BE SEEN CLEARLY FROM A HIGHWAY ADJACENT TO THE ENTRANCE TO THE PREMISES.
- (3) THE LICENSE NUMBER ON THE SIGN SHALL BE IN BLACK LETTERS AT LEAST 4 INCHES HIGH ON A WHITE BACKGROUND.
