## AMENDMENTS TO SENATE BILL NO. 57

(Third Reading File Bill)

## AMENDMENT NO. 1

On page 1, in line 2, before "Provisional" insert "Minor Holding"; in the same line, strike "Restriction for a Minor"; strike beginning with "requiring" in line 4 down through "the" in line 6 and substitute "prohibiting the holder of a provisional driver's license who is a"; in line 6, after "passengers" insert "except under certain circumstances"; in line 7, strike "restriction" and substitute "prohibition"; in line 9, after "enforce" insert "a violation of"; in line 10, strike "awarding" and substitute "assessing"; in line 11, after "license;" insert "authorizing the Motor Vehicle Administration to suspend or revoke an individual's driver's license under certain circumstances;"; strike beginning with "restriction" in line 11 down through "minor" in line 12 and substitute "prohibition imposed on a minor holding a provisional driver's license"; and in line 15, strike "16-113(d-2)" and substitute "21-1123".

## AMENDMENT NO. 2

On page 2, strike in their entirety lines 2 through 9, inclusive, and substitute:

"<u>21-1123.</u>

- (A) (1) THE PROVISIONS OF THIS SUBSECTION DO NOT APPLY IF THE HOLDER OF THE PROVISIONAL DRIVER'S LICENSE IS DRIVING WHILE ACCOMPANIED BY AND UNDER THE IMMEDIATE SUPERVISION OF AN INDIVIDUAL WHO:
  - (I) IS AT LEAST 21 YEARS OLD;
- (II) HAS BEEN LICENSED FOR AT LEAST 3 YEARS IN THIS STATE OR IN ANOTHER STATE TO DRIVE VEHICLES OF THE CLASS THEN BEING DRIVEN BY THE HOLDER OF THE PROVISIONAL DRIVER'S LICENSE; AND

- (III) IS SEATED BESIDE THE HOLDER OF THE PROVISIONAL DRIVER'S LICENSE.
- (2) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, A HOLDER OF A PROVISIONAL DRIVER'S LICENSE WHO IS UNDER THE AGE OF 18 YEARS MAY NOT DRIVE A MOTOR VEHICLE WITH A PASSENGER UNDER THE AGE OF 18 YEARS.
  - (3) THE PROHIBITION UNDER PARAGRAPH (2) OF THIS SUBSECTION:";

in lines 10, 13, 16, and 19, strike "1.", "2.", "(2)", and "(3)", respectively, and substitute "(I)", "(II)", "(B)", and "(C)", respectively; in line 11, strike "181ST" and substitute "151ST"; in line 13, after "IS" insert ":

<u>1.</u>";

in line 15, after "LICENSEE" insert "; OR

2. <u>A RELATIVE OF THE LICENSEE WHO RESIDES AT THE SAME ADDRESS AS THE LICENSEE</u>";

strike beginning with "THE" in line 16 down through "SUBSECTION" in line 17 and substitute "THIS SECTION"; in line 19, strike "SUBSECTION" and substitute "SECTION"; and after line 20, insert:

- "(D) (1) IF THE ADMINISTRATION RECEIVES SATISFACTORY EVIDENCE THAT AN INDIVIDUAL HAS VIOLATED THIS SECTION, THE ADMINISTRATION MAY SUSPEND OR REVOKE THE INDIVIDUAL'S DRIVER'S LICENSE.
- (2) AN INDIVIDUAL MAY REQUEST A HEARING AS PROVIDED FOR A SUSPENSION OR REVOCATION UNDER TITLE 16, SUBTITLE 2 OF THIS ARTICLE.".
