AMENDMENTS TO HOUSE BILL NO. 618
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 13, after “terms;” insert “authorizing the Board to waive certain requirements under certain circumstances;”.

AMENDMENT NO. 2

On page 5 in line 13, and on page 8 in line 34, in each instance, after “PHARMACY” insert “EDUCATION”.

AMENDMENT NO. 3

On page 11, in line 33, after “PHARMACY” insert “UNDER THE SUPERVISION OF A LICENSED PHARMACIST”.

On page 12, in line 20, after “IN” insert “OR HAS COMPLETED”; and in line 21, after “12-301(B)” insert “OF THIS SUBTITLE”.

AMENDMENT NO. 4

On page 23, in line 28, strike “OR” and substitute “AND”.

On page 24, in lines 8 and 12, in each instance, strike “2003” and substitute “2005”; after line 23, insert:

“(G) (1) SUBJECT TO THE PROVISIONS OF THIS SUBSECTION, THE BOARD MAY WAIVE ANY REQUIREMENT OF THIS SUBTITLE FOR AN INDIVIDUAL WHO IS REGISTERED OR HAS WORKED AS A PHARMACY TECHNICIAN IN ANY OTHER STATE.

(2) THE BOARD MAY GRANT A WAIVER UNDER THIS SUBSECTION ONLY IF THE APPLICANT:

(Over)

(I) PAYS THE APPLICATION FEE REQUIRED BY THE BOARD UNDER § 12-6B-03 OF THIS SUBTITLE; AND

(II) 1. PROVIDES ADEQUATE EVIDENCE THAT THE APPLICANT BECAME REGISTERED IN THE OTHER STATE UNDER REQUIREMENTS SUBSTANTIALLY EQUIVALENT TO THE REGISTRATION REQUIREMENTS OF THIS SUBTITLE; OR

2. HAS WORKED AS A PHARMACY TECHNICIAN IN THE OTHER STATE AND CAN SATISFY ANY REQUIREMENTS ESTABLISHED IN REGULATIONS ADOPTED BY THE BOARD.”;

in line 32, strike “OR” and substitute “AND”; and in line 34, after “12-6B-02(B)(4)(I)” insert “OF THIS SUBTITLE”.

AMENDMENT NO. 5

On page 25, in line 12, strike “CERTIFICATES” and substitute “REGISTRATIONS”; and in line 14, strike “CERTIFYING” and substitute “REGISTERING”.

On page 33, in line 2, strike “certification” and substitute “registration”.
