On page 6, after line 25, insert:

  SUBSECTION (B)(4)(IV) OF THIS SECTION.
- (J) ON OR BEFORE SEPTEMBER 1 OF EACH YEAR, THE SECRETARY OF HEALTH AND MENTAL HYGIENE SHALL SUBMIT A REPORT IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE TO THE JOINT COMMITTEE ON PENSIONS THAT PROVIDES:
- (1) THE NUMBER OF REHIRED RETIRES UNDER SUBSECTION (B)(4)(IV) OF THIS SECTION;
- (2) THE ANNUAL SALARY OF EACH REHIRED RETIREE AT THE TIME OF RETIREMENT AND THE CURRENT ANNUAL SALARY OF EACH REHIRED RETIREE;
- (3) THE NUMBER OF HEALTH CARE PRACTITIONERS HIRED WHO ARE NOT RETIREES; AND
- (4) THE ANNUAL SALARY OF EACH HEALTH CARE PRACTITIONER WHO IS HIRED.".
