- 1 (2) The State's Attorney may not engage in the private practice of law at 2 any time in any jurisdiction during the State's Attorney's tenure of office. THE STATE'S ATTORNEY MAY APPOINT A DEPUTY STATE'S (3) (I) 4 ATTORNEY. THE DEPUTY STATE'S ATTORNEY SHALL SERVE AT THE (II)6 PLEASURE OF THE STATE'S ATTORNEY AND SHALL PERFORM THE WORK AS MAY BE 7 DIRECTED BY THE STATE'S ATTORNEY OR AS AUTHORIZED BY LAW.
