 SYSTEM USED BY THE STATE OR ANY POLITICAL SUBDIVISION THAT PROVIDE
 INDIVIDUALS:

AND BE IT FURTHER ENACTED, That the Governor shall allocate the resources required to implement the requirements of Section 1 of this Act, including any gift received by the State for the purposes of this Act under § 2-201 of the State Finance and Procurement Article, or, except for previously committed federal funds received by the State to implement the requirements of The Help America Vote Act 2002, any federal or other special funds or grant received by the State in accordance with federal and State law for the purposes of this Act by fiscal year 2006.
