3 (A) WITH THE CONSENT OF A LICENSED REAL ESTATE BROKER, ONE OR MORE
4 LICENSED REAL ESTATE SALESPERSONS AND LICENSED ASSOCIATE REAL ESTATE
5 BROKERS WHO ARE AFFILIATED WITH THE LICENSED REAL ESTATE BROKER MAY
6 ORGANIZE AND WHOLLY OWN A LIMITED LIABILITY COMPANY UNDER THE
7 MARYLAND LIMITED LIABILITY COMPANY ACT.

8 (B) A LIMITED LIABILITY COMPANY MAY BE ORGANIZED AND OWNED UNDER
