20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 21 MARYLAND, That the Laws of Maryland read as follows:

3 (a) Except as otherwise provided in this section, a family day care home may
4 not operate unless it is registered.

5 (b) A family day care home is not required to be registered if the day care
6 provider:

7 (1) is related to each child by blood or marriage;

8 (2) is a friend of each child's parents or legal guardian and the care is
9 provided on an occasional basis; or

10 (3) has received the care of the child from a child placement agency
11 licensed by the Administration or by a local department.

12 (c) A person may not advertise a family day care home or family day care
13 service unless the family day care home is registered under the provisions of this Part
14 V of this subtitle.

15 (d) An employee of the Administration charged with the investigation and
16 enforcement of child care regulations or the chief licensing agent in a regional office of
17 the Administration may serve a civil citation to a person found in violation of this
18 section.
