5 (A) (1) IN THIS SECTION, "INTERNATIONAL TRADE AGREEMENT" MEANS A
6 TRADE AGREEMENT BETWEEN THE FEDERAL GOVERNMENT AND A FOREIGN
7 COUNTRY TO WHICH THE STATE, AT THE REQUEST OF THE FEDERAL GOVERNMENT,
8 IS A PARTY.

9(2)"INTERNATIONAL TRADE AGREEMENT" DOES NOT INCLUDE A TRADE10AGREEMENT BETWEEN THE STATE AND A FOREIGN COUNTRY TO WHICH THE11FEDERAL GOVERNMENT IS NOT A PARTY.

12 (A) (B) EXCEPT AS PROVIDED IN SUBSECTION (B) (C) OF THIS SECTION, 13 STATE OFFICIALS, INCLUDING THE GOVERNOR, MAY NOT:

14 (1) BIND THE STATE TO THE GOVERNMENT PROCUREMENT RULES OF 15 AN INTERNATIONAL TRADE AGREEMENT; OR

AND BE IT FURTHER ENACTED, That any consent that a State official, including the Governor, has given for the State of Maryland to be bound by the government procurement rules of any international trade agreement on or before the effective date of this Act is declared invalid and the State of Maryland is not bound by the government procurement rules of any international trade agreement for which a State official, including the Governor, has given consent for the State of Maryland to be bound to on or before the effective date of this Act.
