5 (f) "Massage Therapy Advisory Committee" means the Committee established 6 under § 3-5A-04 of this subtitle.

7 (g) (1) "Massage therapy" means the use of manual techniques on soft 8 tissues of the human body including effleurage (stroking), petrissage (kneading), 9 tapotement (tapping), stretching, compression, vibration, and friction, with or 10 without the aid of heat limited to hot packs and heating pads, cold water, or

11 nonlegend topical applications, for the purpose of improving circulation, enhancing

12 muscle relaxation, relieving muscular pain, reducing stress, or promoting health and

13 well-being.

14 (2) "Massage therapy" does not include:

15

(i) The diagnosis or treatment of illness, disease, or injury;

16 (ii) The adjustment, manipulation, or mobilization of any of the 17 articulations of the osseous structures of the body or spine; or

(iii) The laying on of hands, consisting of pressure or movement on a
fully clothed individual, to specifically affect the electromagnetic energy or energetic
field of the human body.

21 (3) In paragraph (2)(iii) of this subsection, "fully clothed" does not 22 require the wearing of footwear.

23 (4) The provisions of paragraph (2) of this subsection do not preclude the
24 application of the modalities described in paragraph (1) of this subsection to an
25 individual who has an injury.

26 (h) "Practice massage therapy" means to engage professionally and for 27 compensation in massage therapy.

(i) "Practice non-therapeutic massage" means to engage professionally andfor compensation in massage therapy in a setting that is not a health care facility.

30 (j) "Registration" means, unless the context requires otherwise, a registration 31 issued by the Board to practice non-therapeutic massage.

32 (k) "Registered massage practitioner" means an individual who is registered33 by the Board to practice non-therapeutic massage.
