A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Law - Robbery - Premises of Fiduciary Institution**

3 FOR the purpose of establishing the crime of robbery or attempted robbery on the  
4 premises of certain fiduciary institutions; defining a certain term; establishing  
5 certain penalties; and generally relating to robbery or attempted robbery on the  
6 premises of a fiduciary institution.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
23 MARYLAND, That the Laws of Maryland read as follows:

24 **Article - Criminal Law**

25 3-406.

26 (A) IN THIS SECTION, "FIDUCIARY INSTITUTION" HAS THE MEANING STATED  
27 IN § 1-301 OF THE FINANCIAL INSTITUTIONS ARTICLE.

1 (B) A PERSON MAY NOT COMMIT OR ATTEMPT TO COMMIT ROBBERY ON THE  
2 PREMISES OF A FIDUCIARY INSTITUTION.

3 (C) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY AND ON  
4 CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 30 YEARS.

6 (a) In this section, "crime of violence" means:

7 (1) abduction;

8 (2) arson in the first degree;

9 (3) kidnapping;

10 (4) manslaughter, except involuntary manslaughter;

11 (5) mayhem;

12 (6) maiming, as previously proscribed under former Article 27, §§ 385  
13 and 386 of the Code;

14 (7) murder;

15 (8) rape;

16 (9) robbery under [§ 3-402 or § 3-403] § 3-402, § 3-403, OR § 3-406 of this  
17 article;

18 (10) carjacking;

19 (11) armed carjacking;

20 (12) sexual offense in the first degree;

21 (13) sexual offense in the second degree;

22 (14) use of a handgun in the commission of a felony or other crime of  
23 violence;

24 (15) an attempt to commit any of the crimes described in items (1)  
25 through (14) of this subsection;

26 (16) assault in the first degree;

27 (17) assault with intent to murder;

28 (18) assault with intent to rape;

29 (19) assault with intent to rob;

1 (20) assault with intent to commit a sexual offense in the first degree; and

2 (21) assault with intent to commit a sexual offense in the second degree.

5 (b) (1) "Fiduciary institution" means:

6 (i) A national banking association;

7 (ii) A State banking institution;

8 (iii) An other-state bank that maintains a branch in this State;

9 (iv) A credit union that is organized under the laws of this State or  
10 of the United States;

11 (v) Any other organization that is organized under the banking  
12 laws of this State and subject to the supervision of the Commissioner; or

13 (vi) A savings and loan association that is organized under the laws  
14 of this State or of the United States.

15 (2) "Fiduciary institution" does not include any person licensed by the  
16 Commissioner under Title 11 of this article.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
18 June 1, 2005.
