- 3 FOR the purpose of authorizing the Board of License Commissioners of Carroll
- 4 County to issue a special beer festival license; specifying the scope of the license;
- 5 establishing a certain fee; specifying certain requirements imposed on
- 6 applicants for the license; requiring the Board to approve the time and location
- 7 for the special beer festival under certain conditions; requiring the Board to
- ensure the primary focus of the festival; requiring the Board to adopt certain regulations for a certain purpose; providing that this Act does not prohibit a
- licensee from holding another alcoholic beverages license of a different class or
- nature; defining a certain term; and generally relating to special beer festival

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That the Laws of Maryland read as follows:
- 20 Article 2B Alcoholic Beverages

- 22 (A) IN THIS SECTION, "BOARD" MEANS THE BOARD OF LICENSE
- 23 COMMISSIONERS FOR CARROLL COUNTY.
- 24 (B) THE BOARD MAY ISSUE A SPECIAL BEER FESTIVAL LICENSE.
- 25 (C) A SPECIAL BEER FESTIVAL LICENSE ENTITLES THE HOLDER TO DISPLAY
- 26 AND SELL AT RETAIL BEER FOR CONSUMPTION ON OR OFF THE LICENSED PREMISES
- 27 ON THE DAYS AND FOR THE HOURS DESIGNATED FOR THE SPECIAL BEER FESTIVAL
- 28 IN CARROLL COUNTY.

- 1 (D) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE, AN
- 2 APPLICANT FOR A SPECIAL BEER FESTIVAL LICENSE SHALL BE THE HOLDER OF A
- 3 CURRENT RETAIL ALCOHOLIC BEVERAGES LICENSE ISSUED IN THE STATE, A CLASS 5
- 4 BREWERY LICENSE, OR A CLASS 7 MICRO-BREWERY LICENSE.
- 5 (E) THE LICENSE FEE IS \$200 FOR A ONE-DAY OR TWO-DAY FESTIVAL.
- 6 (F) THE BOARD SHALL:
- 7 (1) APPROVE ONE WEEKEND FOR THE SPECIAL BEER FESTIVAL THAT
- 8 DOES NOT FALL ON THE DATES CHOSEN FOR THE CUMBERLAND AND SHENANDOAH
- 9 VALLEY WINE FESTIVAL IN WASHINGTON COUNTY, OR THE MARYLAND WINE
- 10 FESTIVAL IN CARROLL COUNTY, OR THE ANNE ARUNDEL BEER AND WINE FESTIVAL;
- 11 (2) APPROVE A NONLICENSED PREMISES IN CARROLL COUNTY FOR THE
- 12 SPECIAL BEER FESTIVAL; AND
- 13 (3) ENSURE THAT THE PRIMARY FOCUS OF THE SPECIAL BEER
- 14 FESTIVAL IS THE PROMOTION OF MARYLAND BEER.
- 15 (G) THIS SECTION DOES NOT PROHIBIT THE LICENSEE FROM HOLDING
- 16 ANOTHER ALCOHOLIC BEVERAGES LICENSE OF A DIFFERENT CLASS OR NATURE.
- 17 (H) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION.
- 18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 19 October 1, 2005.
