A BILL ENTITLED

1 AN ACT concerning

Education - General Assembly Scholarships - Modification of Programs

3 FOR the purpose of altering the Senatorial and Delegate Scholarship Programs to

- 4 require that the moneys appropriated under the programs be awarded by the
- 5 Office of Student Financial Assistance in the Maryland Higher Education
- 6 Commission; requiring the Office to ensure that the awards are distributed in a

7 certain manner and that certain student populations are served; requiring the

- 8 Office to adopt certain guidelines; requiring that certain awards be apportioned 9 among certain legislative districts; repealing certain provisions of law relating
- among certain legislative districts; repeating certain provisions of law relating
- 10 to administering a certain examination for Senatorial Scholarships and

11 awarding Delegate Scholarships for part-time students; making certain stylistic

12 changes; permitting certain recipients to continue to receive awards under

13 certain circumstances; requiring that certain appropriations and unexpended

14 appropriations in certain fiscal years for Senatorial and Delegate scholarships

be transferred and distributed to the Office; and generally relating to modifying

16 the Senatorial and Delegate Scholarship Programs.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

15 MARYLAND, That Section(s) 18-504 of Article - Education of the Annotated Code of 16 Maryland be repealed.

24 (A) IN MAKING AWARDS UNDER THE SENATORIAL AND DELEGATE 25 SCHOLARSHIP PROGRAMS UNDER SUBTITLES 4 AND 5 OF THIS TITLE, THE OFFICE 26 SHALL ENSURE THAT THE AWARDS ARE DISTRIBUTED AMONG:

- 27 (1) FULL-TIME STUDENTS;
- 28 (2) PART-TIME STUDENTS;

29 (3) COMMUNITY COLLEGE AND PROPRIETARY SCHOOL STUDENTS;

30 (4) 4-YEAR COLLEGE UNDERGRADUATE STUDENTS; AND

31 (5) GRADUATE AND PROFESSIONAL SCHOOL STUDENTS.

32 (B) IN ADDITION TO THE ELIGIBILITY CRITERIA ESTABLISHED UNDER
33 SUBTITLES 4 AND 5 OF THIS TITLE AND THE REQUIREMENTS OF SUBSECTION (A) OF
34 THIS SECTION, THE OFFICE SHALL ADOPT GUIDELINES TO IDENTIFY AND ASSIST

THE OFFICE SHALL MAKE AWARDS IN ACCORDANCE WITH THE 8 (B) 9 PROVISIONS OF THIS SUBTITLE AND THE CRITERIA SPECIFIED UNDER § 18-114 OF 10 THIS TITLE. 11 18-402. 12 Except as provided in paragraph (2) of this subsection, each] EACH (a) [(1)]13 applicant for a senatorial scholarship shall[: 14 (i) Take a competitive examination administered by the Office; and 15 (ii) Be] HAVE BEEN accepted for admission in the regular 16 undergraduate, graduate, or professional program at an eligible institution; or be enrolled in a 2-year terminal certificate program in which the course work is 17 18 acceptable for transfer credit for an accredited baccalaureate program in an eligible 19 institution. 20 [(2) An applicant is exempt from the examination if the applicant: 21 (i) Is attending an eligible institution and has completed at least 1 22 year in good academic standing at the institution; 23 Graduated from high school at least 5 years before application (ii) 24 for a senatorial scholarship; 25 Is accepted for admission to a private career institution, if the (iii) 26 institution's curriculum is approved by the Commission, and the institution is 27 accredited by a national accrediting association approved by the United States 28 Department of Education; or 29 Is planning to attend or is attending a Maryland community (iv) 30 college.] 31 (b) Each applicant shall: 32 Be a resident of this State; and (1)33 (2)

At the time of [his] THE initial application, be a resident of the
 legislative district from which [he seeks an appointment] A SENATORIAL AWARD IS
 SOUGHT.

1 (c) [(1)] Each applicant shall demonstrate to the Office a definite financial 2 need[, and each Senator shall consider the financial need of each applicant.

3 (2) Each Senator is the final judge of the financial need of each applicant 4 to whom he awards a scholarship, and the Office may not negate this judgment or 5 impose requirements of time or procedure].

6 (d) Each applicant shall accept any other conditions attached to the award
7 THAT DO NOT CONFLICT WITH THE PROVISIONS OF THIS SUBTITLE OR § 18-114 OF
8 THIS TITLE.

9 18-403.

10 If a [Senator serves from a] legislative district IS comprised of more than one 11 county, THE OFFICE SHALL:

12 (1) CONSIDER APPLICANTS FROM EACH COUNTY IN THE LEGISLATIVE 13 DISTRICT; AND

30 (c) (1) A senatorial scholarship may be awarded in \$100 increments.
31 However, an award for a single year may not be less than \$400 or more than \$2,000.

6 (3) Continues to be a student at the institution and takes at least 6 7 semester hours of courses each semester leading to a degree.

8 (c) Any recipient of a senatorial scholarship may use up to one-half of the 9 yearly award for summer school if the recipient is scheduled to graduate immediately 10 after the fall academic semester following summer school.

(d) A recipient of a senatorial scholarship who is enrolled in a terminal

scholarship for 2 years if [he] THE RECIPIENT is a full-time student and otherwise
meets the conditions of subsection (a) of this section, or may hold the scholarship for
4 years if [he] THE RECIPIENT is a part-time student and otherwise meets the
conditions of subsection (b) of this section.

17 (e) Each recipient of a senatorial scholarship who is enrolled in a private
18 postsecondary proprietary institution that is accredited by a national accrediting
19 association approved by the United States Department of Education:

6 Each member of the House of Delegates may select the recipients of the 7 scholarships on any basis that the Delegate considers appropriate.]

32 (a) Each recipient of a [full-time] Delegate Scholarship may use the 33 scholarship to attend summer school.

34 (b) The term of a [full-time] Delegate Scholarship shall be shortened by 35 one-half year for each summer of use.

36 (c) The amount used for summer school may not exceed one-half of the value37 of the award for the next academic year.

2 [As an alternative to the scholarship awards authorized by §§ 18-503 (a) 3 through 18-505 of this subtitle, and subject to the provisions of subsection (b) of this section, during each year in Office each Delegate may award scholarships in a total 4 5 amount equal to four times the tuition and mandatory fees for a full-time 6 undergraduate student enrolled at the University of Maryland, College Park for the

24 Beginning in fiscal year 1996, each Delegate may authorize the Office of [(a) Student Financial Assistance to award all or a portion of the funds authorized under 25 this subtitle to eligible recipients of an Educational Excellence Award who reside in 26 the Delegate's legislative district. 27

37 increased awards during fiscal year 2006, shall continue to be eligible to receive the

1 full amount of that award for the duration of the eligibility period applicable to that2 recipient.

3 SECTION 5. AND BE IT FURTHER ENACTED, That any appropriation in

4 fiscal year 2006 and any unexpended appropriation available under the Senatorial

5 Scholarship Program or the Delegate Scholarship Program at the conclusion of the

6 current term of the General Assembly on January 9, 2007, that is not needed to meet

7 scholarship awards made to eligible recipients under Section 4 of this Act shall be

8 transferred to and distributed by the Office of Student Financial Assistance in

9 accordance with the provisions of Section 3 of this Act. The unexpended

10 appropriations under this section that are transferred to the Office of Student

11 Financial Assistance shall be allocated by legislative district so that each district

12 receives an amount equal to the balance of scholarship funds previously available

13 under the Senatorial and Delegate Scholarship Programs that had not been awarded

14 by that district's Senators and Delegates during the current legislative term.

15 SECTION 6. AND BE IT FURTHER ENACTED, That this Act shall take effect 16 July 1, 2005.
