A BILL ENTITLED

1 AN ACT concerning

2 **Task Force to Examine and Establish Boundaries of the Prince George's**
3 **County School Board Districts**
4 **PG 402-05**

5 FOR the purpose of creating a Task Force to Examine and Establish Boundaries of
6 the Prince George's County School Board Districts; providing for the
7 composition of the Task Force; requiring the Task Force to elect a chair from
8 among its members; providing for the staffing of the Task Force; specifying the
9 duties of the Task Force; requiring the Task Force to issue a certain report on or
10 before a certain date; providing for the termination of this Act; and generally
11 relating to the Task Force to Examine and Establish Boundaries of the Prince
12 George's County School Board Districts.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That:

15 (a) There is a Task Force to Examine and Establish Boundaries of the Prince
16 George's County School Board Districts.

17 (b) The Task Force consists of the following members:

18 (1) two members of the Senate of Maryland, appointed by the Chair of
19 the Prince George's County Senate Delegation;

20 (2) two members of the House of Delegates, appointed by the Chair of the
21 Prince George's County House Delegation;

22 (3) two representatives of the Prince George's County Council, appointed
23 by the Chair of the County Council;

24 (4) two representatives of the Prince George's County Executive's Office,
25 appointed by the County Executive; and

26 (5) three citizens of Prince George's County, appointed jointly by the
27 Chair of the Prince George's County Senate Delegation and the Chair of the Prince
28 George's County House Delegation.

1 (c) The Task Force shall elect its chair from among its members.

2 (d) Prince George's County shall provide staff for the Task Force.

3 (e) A member of the Task Force:

4 (1) may not receive compensation; but

5 (2) is entitled to reimbursement for expenses under the Standard State
6 Travel Regulations, as provided in the State budget.

7 (f) The Task Force shall examine the issues and information regarding
8 current and proposed school board districts in Prince George's County and establish
9 new boundaries for the Prince George's County school board districts.

10 (g) On or before December 1, 2005, the Task Force shall issue a report of its
11 findings and recommendations to:

12 (1) the Prince George's County Senate Delegation in the General
13 Assembly;

14 (2) the Prince George's County House Delegation in the General
15 Assembly;

16 (3) the Prince George's County Council; and

17 (4) the Prince George's County Executive.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 July 1, 2005. It shall remain effective for a period of 1 year and 5 months and, at the
20 end of December 1, 2006, with no further action required by the General Assembly,
21 this Act shall be abrogated and of no further force and effect.
