## 2 Maryland Pharmacy Discount Program - Expansion - State Discount

- 3 FOR the purpose of expanding the Maryland Pharmacy Discount Program to include
- 4 additional Medicare beneficiaries and individuals who are not Medicare
- 5 beneficiaries and lack other public or private prescription drug coverage and
- 6 have a certain annual household income; authorizing enrollees in the Program
- 7 to receive a certain discount subsidized by the Department of Health and

- 15 application for an amendment to the State's existing § 1115 demonstration waiver
- 16 necessary to implement the expansion of the Maryland Pharmacy Discount Program,
- 17 as provided under Section 1 of this Act.
- 18 (b) The Department shall apply for federal matching funds subject to budget
- 19 neutrality requirements under § 1115 of the Social Security Act and the availability of
- 20 State funds.
- 21 SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall
- 22 take effect on the date that the Centers for Medicare and Medicaid Services approves
- 23 a waiver amendment applied for in accordance with Section 2 of this Act. The
- 24 Department of Health and Mental Hygiene, within 5 days after receiving notice of the
- 25 approval or denial of the waiver amendment application, shall forward a copy of the
- 26 notice to the Department of Legislative Services, 90 State Circle, Annapolis,
- 27 Maryland 21401. If the waiver amendment applied for in accordance with Section 2 of
- 28 this Act is denied, this Act shall be null and void without the necessity of any further
- 29 action by the General Assembly.
- 30 SECTION 4. AND BE IT FURTHER ENACTED, That, except as provided in
- 31 Section 3 of this Act, this Act shall take effect June 1, 2005.
