## 1 AN ACT concerning

2 Maryland Pharmacy Discount Program - Expansion - State Discount - Eligibility

- 4 FOR the purpose of expanding altering the eligibility requirements of the Maryland
- 5 Pharmacy Discount Program to include additional Medicare beneficiaries and
- 6 <u>cover</u> individuals who are not Medicare beneficiaries and lack other public or
- 7 private prescription drug coverage and have a certain annual household income;
- 8 authorizing enrollees in the Program to receive a certain discount subsidized by
- 9 the Department of Health and Mental Hygiene for certain prescription drugs;
- 10 altering the discount provided to certain Medicare beneficiaries enrolled in the
- Program; altering the price at which an enrollee may purchase certain
- 12 prescription drugs; requiring the Department, on or before a certain date, to
- submit to the Centers for Medicare and Medicaid Services an application for an
- amendment to a certain demonstration waiver; requiring the Department to
- apply for certain federal matching funds; providing that certain enrollees in the
- Program may remain enrolled in the Program through a certain date if the
- application for a certain amendment to a certain demonstration waiver is
- 18 <u>approved;</u> requiring the Department to forward a copy of a certain notice to the
- 19 Department of Legislative Services within a certain number of days after
- 20 receiving notice of the approval or denial of a certain waiver amendment
- 21 application; providing for the effective dates of this Act; providing for the
- 22 termination of this Act under certain circumstances; and generally relating to

BY repealing and reenacting, with amendments, 2 3 Article - Health - General 4 Section 15-124.1 5 Annotated Code of Maryland (2000 Replacement Volume and 2004 Supplement) 6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 7 8 MARYLAND, That the Laws of Maryland read as follows: 9 **Article - Health - General** 10 15-124.1. 11 (a) (1) In this section the following words have the meanings indicated: 12 (2) "Enrollee" means an individual who is enrolled in the Maryland 13 Pharmacy Discount Program. 14 "Program" means the Maryland Pharmacy Discount Program 15 established under this section. There is a Maryland Pharmacy Discount Program within the Maryland 16 17 Medical Assistance Program. 18 The purpose of the Program is to improve the health status of Medicare 19 beneficiaries, AND LOWER-INCOME INDIVIDUALS WHO ARE NOT MEDICARE 20 BENEFICIARIES, AND who lack prescription drug coverage by providing access to 21 lower cost, medically necessary, prescription drugs. 22 The Program shall be administered and operated by the Department as (d) 23 permitted by federal law or waiver. 24 (e) (1) The Program shall be open to: 25 Medicare beneficiaries who lack other public or private 26 prescription drug coverage AND WHO HAVE AN ANNUAL HOUSEHOLD INCOME AT OR BELOW 300 PERCENT OF THE FEDERAL POVERTY GUIDELINES; AND INDIVIDUALS WHO ARE NOT MEDICARE BENEFICIARIES, WHO 28 (II)29 LACK OTHER PUBLIC OR PRIVATE PRESCRIPTION DRUG COVERAGE, AND WHO HAVE 30 AN ANNUAL HOUSEHOLD INCOME BELOW 300 PERCENT OF THE FEDERAL 31 POVERTY LEVEL GUIDELINES. 32 Notwithstanding paragraph (1) of this subsection, enrollment in the 33 Maryland Medbank Program established under § 15-124.2 of this subtitle or the 34 Maryland Pharmacy Assistance Program established under § 15-124 of this subtitle 35 does not disqualify an individual from being eligible for the Program.

- 1 (f) Subject to subsection (g) of this section, an enrollee may purchase
- 2 medically necessary prescription drugs that are covered under the Maryland Medical
- 3 Assistance Program from any pharmacy that participates in the Maryland Medical
- 4 Assistance Program at a price that is based on the price paid by the Maryland
- 5 Medical Assistance Program, minus the aggregate value of any federally mandated
- 6 manufacturers' rebates AND ANY STATE CONTRIBUTION AMOUNT.
- 7 Subject to subsection (g) of this section, and to the extent authorized
- 8 under federal waiver, an enrollee whose annual household income is at or below
- 9 [175] 300 percent of the federal poverty guidelines may receive a discount subsidized
- 10 by the Department that is equal to [35] 22 percent of the price paid by the Maryland
- 11 Medical Assistance Program for each medically necessary prescription drug
- 12 purchased under the Program.
- 13 (g) The Department may establish mechanisms to:
- 14 (1) Recover the administrative costs of the Program;
- 15 (2) Reimburse participating pharmacies in an amount equal to the
- 16 Maryland Medical Assistance price, minus the copayment paid by the enrollee for
- 17 each prescription filled under the Program; and
- 18 (3) Allow participating pharmacies to collect a \$1 processing fee, in
- 19 addition to any authorized dispensing fee, for each prescription filled for an enrollee
- 20 under the Program.
- 21 (h) The Secretary shall adopt regulations to implement the Program.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That:
- 23 (a) On or before September 1, 2005, the Department of Health and Mental
- 24 Hygiene shall submit to the Centers for Medicare and Medicaid Services an
- 25 application for an amendment to the State's existing § 1115 demonstration waiver
- 26 necessary to implement the expansion alterations to the eligibility requirements of
- 27 the Maryland Pharmacy Discount Program, as provided under Section 1 of this Act.
- 28 (b) The Department shall apply for federal matching funds subject to budget
- 29 neutrality requirements under § 1115 of the Social Security Act and the availability of
- 30 State funds.
- 31 (c) If the application for the amendment to the State's § 1115 demonstration
- 32 waiver under this section is approved, all individuals enrolled in the Maryland
- 33 Pharmacy Discount Program on or before the date of approval of the waiver
- 34 amendment application may remain enrolled in the Program through December 31,
- 35 2005.
- 36 SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall
- 37 take effect on the date that the Centers for Medicare and Medicaid Services approves
- 38 a waiver amendment applied for in accordance with Section 2 of this Act. The
- 39 Department of Health and Mental Hygiene, within 5 days after receiving notice of the

  - 5 action by the General Assembly.
