16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article 24 - Political Subdivisions - Miscellaneous Provisions**

19 12-203.

20 (a) (1) The Commission consists of nine members.

1 (2) Each member shall be a registered voter of Washington County who
2 in the previous 4 years has voted in at least two elections, at least one of which shall
3 have been in the gubernatorial election year.

4 (b) The Commission shall be comprised as follows:

5 (1) One member from the Democratic Party Central Committee of
6 Washington County;

7 (2) One member from the Republican Party Central Committee of
8 Washington County;

9 (3) One member from the Washington County Chamber of Commerce;

10 (4) One member from the Washington County Farm Bureau;

11 (5) One member from the League of Women Voters of Washington
12 County;

13 (6) One member from the Western Maryland Central Labor Council;

14 (7) [One member from the Washington County Taxpayers Association;
15 and

16 (8) Two members] ONE MEMBER FROM THE CUMBERLAND VALLEY
17 ASSOCIATED BUILDERS AND CONTRACTORS, INC.;

18 (8) ONE MEMBER FROM THE JOINT VETERANS COUNCIL OF
19 WASHINGTON COUNTY; AND

20 (9) ONE MEMBER at large selected by the Executive Committee of the
21 Washington County Council of PTA's. The president of the Council may be [one of
22 these members] THE MEMBER SELECTED.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2005.
