- 3 FOR the purpose of requiring the Secretary of State to issue a flag to the family of a
- 4 member of the military when the member is killed in the performance of duty;
- 5 requiring the flag to be presented to the family of the deceased by a certain State
- 6 Senator when the deceased is not a member of the military; requiring the flag to
- be presented by the Department of Veterans Affairs when the deceased is a

- 9 family members of certain individuals killed in the performance of duty.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:

- 3 (d) (1) The Secretary of State shall issue a State flag to the family of a
- 4 firefighter, policeman, MEMBER OF THE MILITARY, or sworn member of the office of
- 5 State Fire Marshal who is killed in the performance of duty.
- 6 (2) (I) [The] EXCEPT WHEN THE DECEASED IS A MEMBER OF THE
- 7 MILITARY, THE flag shall be presented to the family of the deceased by the State
- 8 Senator of the legislative district in which the deceased resided or served.
- 9 (II) WHEN THE DECEASED IS A MEMBER OF THE MILITARY, THE
- 10 FLAG SHALL BE PRESENTED TO THE FAMILY OF THE DECEASED BY THE
- 11 DEPARTMENT OF VETERANS AFFAIRS.
