7 unfair or deceptive trade practice under the Maryland Consumer Protection Act;

2 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS 3 INDICATED.

4 (2) "CELLULAR NUMBER" MEANS THE TELEPHONE NUMBER OF A
5 CELLULAR SUBSCRIBER IN THE STATE THROUGH CELLULAR TELEPHONE OR OTHER
6 WIRELESS TELECOMMUNICATION SERVICE.

7 (3) "CELLULAR SUBSCRIBER" MEANS:

8 (I) AN INDIVIDUAL WHO SUBSCRIBES TO CELLULAR TELEPHONE 9 OR OTHER WIRELESS TELECOMMUNICATION SERVICE IN THE STATE; OR

(II) ANY INDIVIDUAL WHO RESIDES WITH A SUBSCRIBER.

(4) (I) "TELEPHONE DIRECTORY" MEANS A LISTING OF NAMES AND
 TELEPHONE NUMBERS PRODUCED FOR DISTRIBUTION OR SALE IN THE STATE TO
 HOUSEHOLDS AND BUSINESSES.

14 (II) "TELEPHONE DIRECTORY" INCLUDES AN INTERNET-BASED
15 SERVICE THAT PROVIDES TELEPHONE LISTINGS ON REQUEST OF A USER.

16 (B) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A PERSON MAY NOT
17 INCLUDE IN A TELEPHONE DIRECTORY A LISTING OF A CELLULAR NUMBER OF A
18 CELLULAR SUBSCRIBER WITHOUT THE EXPRESS CONSENT OF THE CELLULAR
19 SUBSCRIBER.

20 (C) A PERSON MAY OBTAIN THE EXPRESS CONSENT OF A CELLULAR
21 SUBSCRIBER TO THE INCLUSION OF THE CELLULAR SUBSCRIBER'S CELLULAR
22 NUMBER IN A TELEPHONE DIRECTORY:

23 (1) IN WRITING; OR

24 (2) ORALLY, ONLY IF THE PERSON:

(I) PROMPTLY SENDS CONFIRMATION OF CONSENT TO THE
CELLULAR SUBSCRIBER BY MAIL OR BY ELECTRONIC MAIL, AT THE ELECTION OF
THE CELLULAR SUBSCRIBER, AT THE ADDRESS PROVIDED BY THE CELLULAR
SUBSCRIBER; AND

29(II)PROVIDES TO THE CELLULAR SUBSCRIBER AN EFFECTIVE30MEANS OF REVOKING CONSENT.

31 (D) A PERSON WHO OBTAINS THE CONSENT OF A CELLULAR SUBSCRIBER
32 THAT IS SUBSEQUENTLY REVOKED MAY NOT BE HELD LIABLE UNDER THIS SECTION
33 FOR INCLUSION OF THE CELLULAR NUMBER IN A DIRECTORY THAT IS FINALIZED
34 FOR PUBLICATION BEFORE THE PERSON RECEIVES THE REVOCATION.

35 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect36 October 1, 2005.
