A BILL ENTITLED

1 AN ACT concerning

2 **Academic Facilities Bonding Authority**

3 FOR the purpose of approving certain projects for the acquisition, development, and  
4 improvement of certain academic facilities for the University System of  
5 Maryland; and approving the issuance of bonds by the University System of  
6 Maryland for financing the projects.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
8 MARYLAND, That:

9 (1) In accordance with Title 19 of the Education Article of the Annotated Code  
10 of Maryland (2004 Replacement Volume and 2004 Supplement), each of the following  
11 projects is approved as a project for an academic facility, and the University System of  
12 Maryland may issue, sell, and deliver bonds in the total principal amount of  
13 \$13,125,000 for the purposes of financing and refinancing the costs of these projects:

14 (A) University of Maryland, Baltimore (Baltimore City)

15 (i) Construct Dental School Building

16 (B) University System of Maryland (Montgomery County)

17 (i) Construct Shady Grove Educational Center III;

18 (2) In accordance with Title 19 of the Education Article of the Annotated Code  
19 of Maryland (2004 Replacement Volume and 2004 Supplement), each of the following  
20 capital facilities renewal projects is hereby approved as a project for an academic  
21 facility, and the University System of Maryland may issue, sell, and deliver bonds in  
22 the total principal amount of \$11,875,000 for the purposes of financing and  
23 refinancing the costs of these capital facilities renewal projects:

- 27 (i) Emergency Projects: System-Wide; and

28 (3) The bonds issued under the authority of this Act do not create or constitute  
29 any indebtedness or obligation of the State or of any political subdivision thereof  
30 except the University System of Maryland, and the bonds shall so state on their face

1 nor do the bonds constitute a debt or obligation contracted by the General Assembly of  
2 Maryland or pledge the faith and credit of the State within the meaning of Article III,  
3 Section 34 of the Maryland of Constitution.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
5 June 1, 2005.
