1 (c) A person may not with prurient intent conduct or procure another to 2 conduct visual surveillance of an individual in a private place without the consent of 3 that individual.

4 (d) A person who violates this section is guilty of a misdemeanor and on 5 conviction is subject to imprisonment not exceeding [1 year] 3 YEARS or a fine not 6 exceeding \$2,500 or both.

7 (e) (1) An individual who was under visual surveillance in violation of this 8 section has a civil cause of action against any person who conducted or procured 9 another to conduct the visual surveillance.

10 (2) In an action under this subsection, the court may award actual 11 damages and reasonable attorney's fees.

12 (f) This section does not affect any legal or equitable right or remedy13 otherwise provided by law.

14 (g) This section does not affect the application of § 3-901 of this subtitle.
