- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:

- 16 (d) "Public school employee" means a certificated professional individual
- 17 who is employed by a public school employer or an individual of equivalent status in
- 18 Baltimore City, except for a county superintendent or an individual designated by the
- 19 public school employer to act in a negotiating capacity as provided in § 6-408(b) of
- 20 this subtitle.
- 21 (2) In Montgomery County, "public school employees" include:
- 22 (i) Certificated and noncertificated substitute teachers employed
- 23 by the public school employer for at least 7 days before March 1 of the school fiscal
- 24 year ending June 30, 1978, and each year after; and
- 25 (ii) Home and hospital teachers employed by the public school
- 26 employer for at least 7 days before March 1 of the school fiscal year ending June 30,
- 27 2000, and each year after.

- In Baltimore County, "public school employee" includes: 1 (3) 2 (i) A secondary school nurse, an elementary school nurse, and a 3 special school nurse; and (ii) Supervisory noncertificated employees as defined under § 5 6-501(h) of this title. (4) In Frederick County, "public school employee" includes a social 6 worker employed by a public school employer. In Prince George's County, "public school employee" includes home 8 (5) 9 and hospital teachers and junior reserve officer training (JROTC) instructors. IN CARROLL COUNTY, "PUBLIC SCHOOL EMPLOYEE" INCLUDES 10 (6) 11 SUPERVISORY NONCERTIFICATED EMPLOYEES AS DEFINED UNDER § 6-501(H) OF 12 THIS TITLE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 14 October 1, 2005.
