- 2 Creation of a State Debt Prince George's County Forest Heights Road
 3 Improvements
- 4 FOR the purpose of authorizing the creation of a State Debt in the amount of
- \$3,000,000, the proceeds to be used as a grant to the Mayor and Town Council of
- 6 the Town of Forest Heights for certain development or improvement purposes;
- 7 providing for disbursement of the loan proceeds; establishing a deadline for the
- 8 encumbrance or expenditure of the loan proceeds; and providing generally for
- 9 the issuance and sale of bonds evidencing the loan.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 11 MARYLAND, That:
- 12 (1) The Board of Public Works may borrow money and incur indebtedness on
- 13 behalf of the State of Maryland through a State loan to be known as the Prince
- 14 George's County Forest Heights Road Improvements Loan of 2005 in the total
- 15 principal amount of \$3,000,000. This loan shall be evidenced by the issuance, sale,
- 16 and delivery of State general obligation bonds authorized by a resolution of the Board
- 17 of Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 18 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 19 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 20 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 21 § 8-122 of the State Finance and Procurement Article.
- 22 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 23 and first shall be applied to the payment of the expenses of issuing, selling, and
- 24 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 25 shall be credited on the books of the Comptroller and expended, on approval by the
- 26 Board of Public Works, for the following public purposes, including any applicable
- 27 architects' and engineers' fees: as a grant to the Mayor and Town Council of the Town
- 28 of Forest Heights for the repair and reconstruction of roads, including Marlboro Pike,
- 29 in Forest Heights.
- 30 (4) An annual State tax is imposed on all assessable property in the State in
- 31 rate and amount sufficient to pay the principal of and interest on the bonds, as and

- 1 when due and until paid in full. The principal shall be discharged within 15 years
- 2 after the date of issuance of the bonds.
- 3 (5) The proceeds of the loan must be expended or encumbered by the Board of
- 4 Public Works for the purposes provided in this Act no later than June 1, 2012. If any
- 5 funds authorized by this Act remain unexpended or unencumbered after June 1,
- 6 2012, the amount of the unencumbered or unexpended authorization shall be
- 7 canceled and be of no further effect. If bonds have been issued for the loan, the
- 8 amount of unexpended or unencumbered bond proceeds shall be disposed of as
- 9 provided in § 8-129 of the State Finance and Procurement Article.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 11 June 1, 2005.
