4 5 7 8 9 10	FOR the purpose of exempting a motor vehicle for which a parking placard for individuals with disabilities has been issued from the mandatory inspection and testing requirements of the vehicle emissions inspection program if the owner of the vehicle meets certain disability requirements, the vehicle is driven less than a certain number of miles over certain periods, and the exemption is not prohibited by federal law; making conforming changes; specifying application procedures; and generally relating to exemptions for certain individuals with disabilities from certain vehicle emissions inspection and testing requirements.

22 23	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

A person may apply to the Administration for a parking placard on a form 26 (a)

27 provided by the Administration if the applicant, a dependent of the applicant, or any 28 individual who depends on the applicant for transportation:

16 (d) (1) A placard issued under this section to an applicant described in 17 subsection (a) of this section expires 4 years from the date of issue.
18(2)The placard may be renewed on application with proof of the19 disability.
20 (e) (1) A parking placard for a person with a disability shall be issued:
 (i) Except as provided in item (ii) or item (iii) of this paragraph, in the form of a removable windshield placard capable of being hung from the inside rearview mirror and of a size and design as determined by the Administration;
 (ii) For a vehicle not equipped with an inside rearview mirror or in which the inside rearview mirror is not visible from the rear of the vehicle, in the form of a windshield placard of a size and design as determined by the Administration; or

30(2)A person to whom a parking placard for a person with a disability is31 issued shall display the placard described in this section:

14 (3) The removable windshield placard shall be placed inside a vehicle 15 that is not equipped with an inside rearview mirror, in a position from which the 16 removable windshield placard can be viewed from the outside of the vehicle through 17 the lower portion of the windshield on the driver's side of the vehicle.
18 (4) When displayed, the person to whom a removable windshield placard 19 is issued under this section or under a similar provision of law of any state or country 20 is accorded the privileges contained in § 13-616(g) of this subtitle.

 (1) The person shall have in the person's possession identification issued by the Administration as proof that parking privileges are being utilized by a person with a disability as defined in § 13-616(b)(1) of this subtitle; and
