33 WHEREAS, Thousands of Maryland seniors and individuals with disabilities  
34 live independently in their own homes, which they prefer and which is less costly  
35 than institutional care such as nursing homes; and

1 WHEREAS, Many Maryland seniors and individuals with disabilities currently  
 2 receive personal home care services from individual providers hired directly by the  
 3 individuals under State and federally funded programs; and

4 WHEREAS, Quality personal home care services allow Maryland seniors,  
 5 individuals with disabilities, and the individuals' families the choice of allowing  
 6 seniors and individuals with disabilities to remain in their homes, rather than forcing  
 7 them into institutional care; and

8 WHEREAS, Home- and community-based options are less costly than nursing  
 9 homes and other institutional care, and therefore save Maryland taxpayers  
 10 significant amounts of money; and

11 WHEREAS, There is a growing shortage of qualified individuals to provide  
 12 personal home care services to seniors and individuals with disabilities in the State;  
 13 and

14 WHEREAS, Consumers are well served by programs that support  
 15 self-direction, individual autonomy, dignity, and choice; now, therefore,
