SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
MARYLAND, That the Laws of Maryland read as follows:

Article 23A - Corporations - Municipal

Pursuant to the provisions of § 5 of Article XI-E of the Constitution of 5 (a) 6 Maryland prohibiting any municipal corporation classified by the General Assembly 7 under the provisions of § 2 of Article XI-E of the Constitution of Maryland from 8 levying any type of tax, license fee, franchise tax or fee which was not in effect in the 9 municipal corporation on January 1, 1954, unless it has received the express 10 authorization of the General Assembly for that purpose, by a general law which in its 11 terms and its effect applies alike to all similarly classified municipal corporations, the 12 General Assembly hereby expressly authorizes all municipal corporations in this 13 State within the class created by § 10 of this article for the purpose of financing the 14 design, construction, establishment, extension, alteration or acquisition of adequate 15 storm drainage systems, for the purpose of financing the design, acquisition, 16 establishment, improvement, extension, operation or alteration of public parking 17 facilities, or pedestrian malls, for the purpose of financing the design, acquisition, 18 erection, construction, improvement and maintenance of street and area lighting, FOR 19 THE PURPOSE OF FINANCING THE CAPITAL AND OPERATING COSTS TO ENHANCE 20 POLICE, FIRE PROTECTION, AND RESCUE SERVICES, and for the purposes set forth in 21 § 2(b)(35) of this article, to create within their respective corporate limits special 22 taxing districts for these purposes and to levy on all real and personal property 23 located within these special taxing districts an ad valorem tax at a rate sufficient to 24 provide adequate annual revenues to pay the principal and interest on any bonds or 25 other obligations of the municipality issued for these purposes as the principal and 26 interest become due, and to pay the costs of operating and maintaining these facilities 27 and activities. These taxes shall be levied in the same manner, upon the same

28 assessments, for the same period or periods, and as of the same date or dates of

29 finality as are now or may hereafter be prescribed.

30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 31 July 1, 2005.
