BE IT ENACTED BY THE GENERAL ASSEMBLY OF 3 MARYLAND, That the Laws of Maryland read as follows: 4 **Article - Estates and Trusts** 5 13-301. 6 (a) In this subtitle the following words have the meanings indicated. "QUALIFIED MINOR'S TRUST" MEANS A TRUST: 7 (N) (1) OF WHICH A MINOR IS THE SOLE BENEFICIARY DURING THE (I) 9 MINOR'S LIFETIME; AND 10 (II) THAT MEETS THE REQUIREMENTS OF § 2503(C) OF THE 11 INTERNAL REVENUE CODE AND THE REGULATIONS IMPLEMENTING THAT SECTION. - 1 [(b)] (C) On petition of an interested person or the minor if the minor has
- 2 attained the age of 14 years, the court may order the custodian to deliver or pay to the
- 3 minor or expend for the minor's benefit so much of the custodial property as the court

- 5 [(c)] (D) A delivery, payment, or expenditure under this section is in addition
- 6 to, not in substitution for, and does not affect any obligation of a person to support the
