A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws - Provisional Driver's License Restriction for a Minor -**
3 **Prohibition Against Minors as Passengers**

4 FOR the purpose of requiring the Motor Vehicle Administration to impose a certain
5 restriction on the original provisional driver's license of a minor that prohibits
6 the minor from transporting individuals under a certain age as passengers;
7 requiring the restriction to be in effect for a certain period of time; exempting
8 certain passengers from the provisions of this Act; authorizing a police officer to
9 enforce this Act only as a secondary violation; providing that a violation of this
10 Act is a moving violation for the purpose of awarding points against a driver's
11 license; and generally relating to a restriction on the original provisional driver's
12 license of a minor.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article - Transportation**

21 16-113.

22 (D-2) (1) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II)2 OF THIS
23 PARAGRAPH, THE ADMINISTRATION SHALL IMPOSE ON EACH PROVISIONAL DRIVER'S
24 LICENSE ISSUED TO A LICENSEE UNDER THE AGE OF 18 YEARS A RESTRICTION THAT
25 PROHIBITS THE LICENSEE FROM DRIVING A MOTOR VEHICLE WITH A PASSENGER
26 UNDER THE AGE OF 18 YEARS.

1 (II) THE RESTRICTION IMPOSED UNDER SUBPARAGRAPH (I) OF
2 THIS PARAGRAPH:

3 1. SHALL BE IN EFFECT FROM THE DATE THE PROVISIONAL
4 LICENSE IS ORIGINALLY ISSUED UNTIL THE 181ST DAY AFTER THE PROVISIONAL
5 LICENSE WAS ISSUED; AND

6 2. DOES NOT APPLY TO A PASSENGER WHO IS A SPOUSE,
7 DAUGHTER, SON, STEPDAUGHTER, STEPSON, SISTER, BROTHER, STEPSISTER, OR
8 STEPBROTHER OF THE LICENSEE.

9 (2) A POLICE OFFICER MAY ENFORCE THE PROVISIONS OF THIS
10 SUBSECTION ONLY AS A SECONDARY ACTION WHEN THE POLICE OFFICER DETAINS A
11 DRIVER FOR A SUSPECTED VIOLATION OF ANOTHER PROVISION OF THE CODE.

12 (3) A VIOLATION OF THIS SUBSECTION IS A MOVING VIOLATION FOR THE
13 PURPOSES OF § 16-402 OF THIS TITLE.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2005.
