- 24 performing a public or private contract, except as provided in § 16-202; or

19	(c) A person may be debarred from entering into a contract with the State:
	(1) if the Board finds that the person was established or operates in a manner designed to evade the application of this title or to defeat the purpose of this title;
23 24	(2) if the person is a successor, assignee, subsidiary, or affiliate of a person who is debarred or suspended;
