- 3 Approval Required
- 4 FOR the purpose of providing that the Board of Public Works may not approve the sale, lease, transfer, exchange, grant, or other disposition of certain outdoor
- 6 recreation, open space, conservation, preservation, forest, or park land without
- 7 the express approval of the General Assembly; and submitting this amendment
- 8 to the qualified voters of the State of Maryland for their adoption or rejection.

1 AN ACT concerning

- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, (Three-fifths of all the members elected to each of the two Houses
- 14 concurring), That it be proposed that the Maryland Constitution read as follows:

15 Article XII - Public Works

- 17 (A) The Board of Public Works is hereby authorized, subject to such
- 18 regulations and conditions as the General Assembly may from time to time prescribe,
- 19 to sell the State's interest in all works of Internal Improvement, whether as a
- 20 stockholder or a creditor, and also the State's interest in any banking corporation,
- 21 receiving in payment the bonds and registered debt now owing by the State, equal in
- 22 amount to the price obtained for the State's said interest.
- 23 (B) THE BOARD OF PUBLIC WORKS MAY NOT APPROVE THE SALE, LEASE,
- 24 TRANSFER, EXCHANGE, GRANT, OR OTHER DISPOSITION OF ANY STATE-OWNED OR
- 25 STATE-DESIGNATED OUTDOOR RECREATION, OPEN SPACE, CONSERVATION,

- 1 PRESERVATION, FOREST, OR PARK LAND WITHOUT THE EXPRESS APPROVAL OF THE 2 GENERAL ASSEMBLY.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That the General Assembly
- 4 determines that the amendment to the Maryland Constitution proposed by this Act
- 5 affects multiple jurisdictions and that the provisions of Article XIV, § 1 of the
- 6 Maryland Constitution concerning local approval of constitutional amendments do
- 7 not apply.
- 8 SECTION 3. AND BE IT FURTHER ENACTED, That the aforegoing section
- 9 proposed as an amendment to the Maryland Constitution shall be submitted to the
- 10 legal and qualified voters of this State at the next general election to be held in
- 11 November, 2006 for their adoption or rejection in pursuance of directions contained in
- 12 Article XIV of the Maryland Constitution. At that general election, the vote on this
- 13 proposed amendment to the Constitution shall be by ballot, and upon each ballot
- $14\,$ there shall be printed the words "For the Constitutional Amendment" and "Against
- 15 the Constitutional Amendment," as now provided by law. Immediately after the
- 16 election, all returns shall be made to the Governor of the vote for and against the
- 17 proposed amendment, as directed by Article XIV of the Maryland Constitution, and
- 18 further proceedings had in accordance with Article XIV.
