CHAPTER

1 AN ACT concerning

- 2 Board of Public Works Disposition of Park Lands General Assembly
 3 Approval Required
- 4 FOR the purpose of providing that the Board of Public Works may not approve the
- sale, lease, transfer, exchange, grant, or other <u>permanent</u> disposition of certain
- 6 outdoor recreation, open space, conservation, preservation, forest, or park land
- 7 without the express approval of the General Assembly or of a committee
- 8 <u>designated by the General Assembly in a certain manner;</u> and submitting this
- 9 amendment to the qualified voters of the State of Maryland for their adoption or
- 10 rejection.
- 11 BY proposing an amendment to the Maryland Constitution
- 12 Article XII Public Works
- 13 Section 3
- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, (Three-fifths of all the members elected to each of the two Houses
- 16 concurring), That it be proposed that the Maryland Constitution read as follows:

Article XII - Public Works

- 3 (A) The Board of Public Works is hereby authorized, subject to such
- 4 regulations and conditions as the General Assembly may from time to time prescribe,
- 5 to sell the State's interest in all works of Internal Improvement, whether as a
- 6 stockholder or a creditor, and also the State's interest in any banking corporation,
- 7 receiving in payment the bonds and registered debt now owing by the State, equal in
- 8 amount to the price obtained for the State's said interest.
- 9 (B) THE BOARD OF PUBLIC WORKS MAY NOT APPROVE THE SALE, LEASE,
- 10 TRANSFER, EXCHANGE, GRANT, OR OTHER PERMANENT DISPOSITION OF ANY
- 11 STATE-OWNED OR STATE-DESIGNATED OUTDOOR RECREATION, OPEN SPACE,
- 12 CONSERVATION, PRESERVATION, FOREST, OR PARK LAND WITHOUT THE EXPRESS
- 13 APPROVAL OF THE GENERAL ASSEMBLY OR OF A COMMITTEE THAT THE GENERAL
- 14 ASSEMBLY DESIGNATES BY STATUTE, RESOLUTION, OR RULE.
- 15 SECTION 2. AND BE IT FURTHER ENACTED, That the General Assembly
- 16 determines that the amendment to the Maryland Constitution proposed by this Act
- 17 affects multiple jurisdictions and that the provisions of Article XIV, § 1 of the
- 18 Maryland Constitution concerning local approval of constitutional amendments do
- 19 not apply.
- 20 SECTION 3. AND BE IT FURTHER ENACTED, That the aforegoing section
- 21 proposed as an amendment to the Maryland Constitution shall be submitted to the
- 22 legal and qualified voters of this State at the next general election to be held in
- 23 November, 2006 for their adoption or rejection in pursuance of directions contained in
- 24 Article XIV of the Maryland Constitution. At that general election, the vote on this
- 25 proposed amendment to the Constitution shall be by ballot, and upon each ballot
- 26 there shall be printed the words "For the Constitutional Amendment" and "Against
- 27 the Constitutional Amendment," as now provided by law. Immediately after the
- 28 election, all returns shall be made to the Governor of the vote for and against the
- 29 proposed amendment, as directed by Article XIV of the Maryland Constitution, and
- 30 further proceedings had in accordance with Article XIV.
