	(b) (1) Each student who graduates from a public high school shall receive the same type of diploma or certificate, regardless of the high school attended or the course taken.

1 (2) The diploma or certificate shall state that the student has completed 2 a program of studies satisfactorily in accordance with the requirements of the State 3 Board.

4 (C) (1) THE STATE BOARD SHALL ADOPT REGULATIONS THAT ALLOW A
