3 FOR the purpose of continuing the Maryland Tobacco Authority in accordance with

- 4 the provisions of the Maryland Program Evaluation Act (Sunset Law) by
- 5 extending to a certain date the termination provisions relating to the statutory
- 6 and regulatory authority of the Authority; altering the number of members of
- 7 the Authority, the membership criteria, and the process for nominating
- 8 members; repealing a provision of law for compensation of certain members of
- 9 the Authority; repealing a certain requirement that the Authority conduct
- 10 certain studies and investigations; altering certain fees; requiring that an
- evaluation of the Authority and the statutes and regulations that relate to the
- 12 Authority be performed on or before a certain date; requiring the Authority to
- 13 submit a certain report to certain committees of the General Assembly on or
- 14 before a certain date; and generally relating to the Maryland Tobacco Authority.

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 7 MARYLAND, That the Laws of Maryland read as follows:

Article - Agriculture

9 7-201.1.

10 Subject to the provisions of the Maryland Program Evaluation Act, the

11 provisions of this subtitle and of any rule or regulation relating to the Tobacco

- 12 Authority under this subtitle shall terminate and be of no effect after July 1, [2006]
- 13 2011.

14 7-202.

15 (a) The Authority consists of [eight] SIX members appointed by the Governor 16 as follows:

17 (1) A person familiar with the economics and marketing of tobacco in the18 State to be selected from three nominees submitted by the Secretary;

19 (2) A person in the business of selling leaf tobacco in the State;

20 (3) A person in the business of buying leaf tobacco; and

21 (4) [Five] THREE persons who produce leaf tobacco at the time of their

22 selection and do not have any direct or indirect financial or other interest in the

23 buying or selling of leaf tobacco, except a producer's interest.

24 (B) [They] THE MEMBERS OF THE AUTHORITY APPOINTED IN ACCORDANCE

25 WITH SUBSECTION (A)(4) OF THIS SECTION shall be selected from a list of [15]

26 nominees submitted by the [Maryland Farm Bureau, Inc.] DEPARTMENT. [At least

27 two of the five members shall be members of the political party which received the

28 second highest number of votes in the preceding gubernatorial election. No two

29 producer members of the Authority may be residents of the same county.]

30 [(b)] (C) The term of each member is three years or until his successor is 31 selected and qualifies.

32 [(c)] (D) If a vacancy occurs for any reason, the Governor shall appoint 33 another person to serve for the remaining portion of the unexpired term. Any new

34 appointee for an expired or unexpired term shall be a person with qualifications

35 similar to those of the next previous incumbent, so as to preserve the balance of

36 representation for the several groups provided in this section.

21 Every commission selling agency shall collect from the owner or seller of (a) 22 tobacco sold on its sales floor, a fee not exceeding the rate of [1/5] 1/4 of 1 cent per

23 pound. At any time less than 60 days prior to the opening of the selling season, the

24 Authority may establish a lower rate for that one season in consideration of its need

25 for funds in the next fiscal year, or other potentially available revenues, and funds the

26 State Comptroller holds on its account. Any lower rate shall be at a level sufficient to

27 keep the special fund at an adequate level to meet requirements of this subtitle.

30 (a) On or before December 15 of the 2nd year before the evaluation date of a 31 governmental activity or unit, the Legislative Policy Committee, based on a 32 preliminary evaluation, may waive as unnecessary the evaluation required under this

33 section.

34 (b) Except as otherwise provided in subsection (a) of this section, on or before 35 the evaluation date for the following governmental activities or units, an evaluation
