11 SECTION 13. AND BE IT FURTHER ENACTED, That:

12 (1) No later than June 1, 2003, the Secretary of Health and Mental Hygiene

13 and the carrier that is required to offer the Short-Term Prescription Drug Subsidy

14 Plan under Title 15, Subtitle 6 of the Health - General Article shall transfer all Plan

15 records, data, and other information necessary to operate and administer the Senior 16 Prescription Drug Program established under this Act to the Board of the Maryland

17 Health Insurance Plan.

18 (2) Each individual enrolled in the Short-Term Prescription Drug Subsidy

19 Plan, established under Title 15, Subtitle 6 of the Health - General Article, on June

20 30, 2003 shall, at the option of the enrollee and subject to the payment of all necessary 21 premiums and copayments, be automatically enrolled in the Senior Prescription Drug

(3) It is the intent of the General Assembly that the transition of enrollees

1 or the availability of comparable prescription drug benefits provided by Medicare

2 under Title XVIII of the Social Security Act, as amended, with no further action

3 required by the General Assembly, the Senior Prescription Drug Program established

4 under Title 14, Subtitle 5, Part II, as amended, shall be abrogated and of no further
