- 1 (1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE,

- 3 PRESCRIPTION DRUGS UNDER HEALTH INSURANCE POLICIES OR CONTRACTS THAT
- 4 ARE ISSUED OR DELIVERED IN THE STATE; AND
- 5 (2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE, DIRECTLY
