1 AN ACT concerning

2 Cecil County - Dog and Kennel Licenses

- 3 FOR the purpose of excluding Cecil County from certain provisions of law relating to
- 4 dog and kennel licenses; requiring that the fees, terms, and forms for dog and
- 5 kennel licenses in Cecil County be determined by the County Commissioners of
- 6 Cecil County; and generally relating to requirements for dog and kennel licenses
- 7 in Cecil County.
- 8 BY repealing and reenacting, with amendments,
- 9 Article 24 Political Subdivisions Miscellaneous Provisions

- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:

15 Article 24 - Political Subdivisions - Miscellaneous Provisions

16 11-501.

- 17 (a) Except in Carroll County, CECIL COUNTY, Montgomery County, Howard
- 18 County, and Washington County, on or before the first day of July of each year, the
- 19 owner of any dog, six months old or over, shall apply either orally or in writing, to the
- 20 county treasurer or to the tax collecting officer in said county for a license for each
- 21 such dog owned or kept by him, and such application shall be accompanied by a fee of
- 22 one dollar (\$1.00) for each male dog or each spayed female dog, and a fee of two
- 23 dollars (\$2.00) for each unspayed female dog, and provided that kennel license shall

- 1 be issued for ten dollars (\$10.00) to persons owning or keeping not in excess of
- 2 twenty-five dogs and that a kennel license fee of twenty dollars (\$20.00) shall be
- 3 issued to persons keeping more than twenty-five dogs. The said license or fee shall be
- 4 the only license or tax required for the ownership or keeping of said dog or dogs. Such
- 5 license shall be issued on a form prepared and supplied by the county commissioners.
- 6 Such license shall be dated and numbered, and shall contain a description of the dog
- 7 licensed. Except in Carroll County, CECIL COUNTY, Montgomery County, Howard
- 8 County, and Washington County, all licenses shall be void upon the first day of July of
- 9 the following year. The county commissioners shall also furnish, and the county
- 10 treasurer, or tax collecting officer issuing the license, shall issue, with each license, a
- 11 metal tag. Such tag shall be affixed to a substantial collar. The collar shall be
- 12 furnished by the owner, and with the tag attached shall at all times be kept on the dog
- 13 for which the license is issued, except when confined in the kennel or when hunting in
- 14 charge of an attendant.
- 15 (b) In Calvert County the fees for dog licenses shall be determined by the
- 16 County Commissioners. However, before establishing or altering any license fee, the
- 17 Calvert County Commissioners shall advertise the proposed fee for 2 consecutive
- 18 weeks in at least 2 newspapers of general circulation in Calvert County. All dog
- 19 licenses will expire on June 30. Any license valid on July 1, 1973, shall remain valid
- 20 through June 30, 1974.
- 21 (c) In Harford County all applications for licenses under the provisions of this
- 22 section shall be made on or before the thirty-first day of December of each year and
- 23 all licenses issued shall be void upon the thirty-first day of December of the following
- 24 year. Any license issued under the provisions of this section as of July 1, 1950, shall be
- 25 valid until December 31, 1951. The license fee for each unspayed female dog shall be
- 26 three dollars (\$3.00).
- 27 (d) In Montgomery County:
- 28 (1) The fees for dogs shall be determined by the County Executive of the
- 29 county; and
- 30 (2) A dog license shall expire when a rabies vaccination certification
- 31 issued under § 18-319(a)(3) of the Health General Article expires.
- 32 (e) In St. Mary's County the license fees for dogs, including the fee for any
- 33 kennel license, shall be determined by the County Commissioners of the county and
- 34 shall be payable on or before the thirtieth day of June of each year, and all such
- 35 licenses issued shall be void upon the thirtieth day of June the following year. The
- 36 County Commissioners of St. Mary's County are authorized and directed to appoint
- 37 the necessary agents to collect said license fees from owners of dogs who have not paid
- 38 the required license fees by the first day of August in each year, and there shall be
- 39 added to the fee of such delinquent owner a penalty of one dollar (\$1.00) per license.
- 40 Every dog warden appointed in St. Mary's County shall have all the powers of a
- 41 constable or other peace officer.

- 1 (f) In Talbot County the fee for a male dog or a spayed female shall be \$1.50 2 and the fee for an unspayed female dog shall be \$3.00.
- 3 (g) In Charles County the fee for dogs shall be determined by the County 4 Commissioners of the county.
- 5 (h) In Howard County:
- 6 (1) The fee for dog and kennel licenses is determined by the County 7 Executive with the approval of the County Council; and
- 8 (2) A dog license shall expire as specified by county law.
- 9 (i) Repealed.
- 10 (j) In Worcester, Kent, and Caroline counties the fee for dog and kennel
- 11 licenses shall be determined by the county commissioners.
- 12 (k) In Frederick County, the license fees for dogs, including the fee for any
- 13 kennel license, shall be determined by the County Commissioners of the county.
- 14 (1) In Wicomico County:
- 15 (1) The fees for dog and kennel licenses shall be determined by the
- 16 County Council of Wicomico County; and
- 17 (2) A dog license shall expire as specified by county law.
- 18 (m) In Anne Arundel County, the fees for dog and kennel licenses shall be
- 19 determined by the County Council of Anne Arundel County. A dog license shall expire
- 20 when a rabies vaccination certificate issued under § 18-319(a)(3) of the Health -
- 21 General Article expires.
- 22 (n) In Garrett County, the license fee for dogs, including the fee for any kennel
- 23 license, shall be determined by the County Commissioners of the county.
- 24 (o) (1) This subsection applies only to Carroll County.
- 25 (2) The Carroll County Commissioners shall set the fees, the term, and
- 26 the form for dog licenses and kennel licenses pursuant to the authority under §
- 27 11-511 of this subtitle.
- 28 (P) IN CECIL COUNTY, THE FEES, THE TERMS, AND THE FORMS FOR DOG AND
- 29 KENNEL LICENSES SHALL BE DETERMINED BY THE COUNTY COMMISSIONERS OF
- 30 CECIL COUNTY.
- 31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 32 October 1, 2005.
