A BILL ENTITLED

1 AN ACT concerning

2 **Cecil County - Tax Sales - Auctioneer's Fee**

3 FOR the purpose of altering the auctioneer's fee in Cecil County allowed as an
4 expense relating to certain tax sales of property; and generally relating to the
5 auctioneer's fee in Cecil County allowed as an expense relating to certain tax
6 sales of property.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article - Tax - Property**

15 14-813.

16 (e) (2) The auctioneer's fee allowed in paragraph (1) of this subsection shall
17 be:

18 (i) except in Baltimore City, Caroline County, Carroll County,
19 CECIL COUNTY, Dorchester County, Kent County, Queen Anne's County, Somerset
20 County, Wicomico County, or Worcester County:

21 1. for any date when 1, 2, or 3 properties are sold, an amount
22 not to exceed \$10; and

23 2. for any date when 4 or more properties are sold, \$3 for
24 each property sold;

25 (ii) in Caroline County, Dorchester County, and Somerset County,
26 \$10 for each property sold, but in no event may the auctioneer's fee be less than \$50
27 a day or greater than \$200 a day;

- 1 (iii) in Kent County, an amount not exceeding \$7.50 for each
2 property sold;
- 3 (iv) in CECIL COUNTY AND Queen Anne's County, \$7.50 for each
4 property sold;
- 5 (v) in Wicomico County, \$8 for each property sold;
- 6 (vi) in Worcester County, the greater of \$8 for each property sold or
7 \$300, to be allocated pro rata among each property sold;
- 8 (vii) in Baltimore City:
- 9 1. for any date when 1, 2, or 3 properties are sold, an amount
10 not to exceed \$10;
- 11 2. for any date when 4 or more properties are sold, \$3 for
12 each property sold; and
- 13 3. in an electronic sale, an amount not to exceed \$10 for each
14 property sold; and
- 15 (viii) in Carroll County, the amount set by the Carroll County
16 Commissioners.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 July 1, 2005.
