## 1 Article - Election Law 2 14-105. 3 (a) Except as provided in subsection (f) of this section, an applicable contribution made by an officer, director, or partner of a business entity doing public 5 business shall be attributed to the business entity. Except as provided in subsection (f) of this section, each officer, director, or 6 partner of a business entity doing public business who makes an applicable 8 contribution shall report the applicable contribution to the chief executive officer of the business entity. 10 (c) A contribution by an officer, director, partner, employee, agent, or other 11 person made at the suggestion or direction of a business entity doing public business 12 shall be attributed to the business entity. 13 Each officer, director, partner, employee, agent, or other person who, at the 14 suggestion or direction of a business entity doing public business, makes an 15 applicable contribution shall report the applicable contribution to the chief executive 16 officer of the business entity. 17 Business done with a governmental entity by a subsidiary of a (e) (1) business entity shall be attributed to the business entity if 30% or more of the equity of the subsidiary is owned or controlled by the business entity. 20 Applicable contributions made by or attributed to a subsidiary 21 described in paragraph (1) of this subsection shall be attributed to the business entity.
