- 3 FOR the purpose of requiring an applicant for certain State health programs to
- 4 identify the employer of a proposed beneficiary or the employer of a certain
- 5 family member of a proposed beneficiary; requiring the Department of Health
- 6 and Mental Hygiene to publish a report identifying certain employers and
- 7 providing certain information; requiring the report to protect the confidentiality
- 8 of individuals in the State health programs; requiring the report to be made
- available to the public; requiring the Department to report to the General 9
- Assembly on or before a certain date; defining certain terms; and generally 10
- relating to the disclosure of information regarding employers of individuals 11

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 18
- 19 MARYLAND, That the Laws of Maryland read as follows:

"STATE HEALTH PROGRAM" MEANS: 4 (3) 5 (I) THE MARYLAND MEDICAID PROGRAM; THE MARYLAND CHILDREN'S HEALTH PROGRAM; OR 6 (II)7 ANY STATE HEALTH CARE PROGRAM THAT PROVIDES MEDICAL (III)8 AND OTHER HEALTH SERVICES. 9 (B) (1) AN APPLICANT FOR A STATE HEALTH PROGRAM SHALL IDENTIFY 10 THE EMPLOYER OF THE PROPOSED BENEFICIARY OF THE MEDICAL AND OTHER 11 HEALTH CARE SERVICES. 12 IF THE PROPOSED BENEFICIARY OF THE MEDICAL AND OTHER 13 HEALTH CARE SERVICES IS NOT EMPLOYED, THE APPLICANT SHALL IDENTIFY THE 14 EMPLOYERS OF ALL FAMILY MEMBERS OF THE PROPOSED BENEFICIARY WHOSE 15 INCOME IS COUNTED AS FAMILY INCOME. THE DEPARTMENT SHALL PUBLISH A REPORT IDENTIFYING ALL (C) 16 (1) 17 EMPLOYERS THAT EMPLOY 25 OR MORE RECIPIENTS OF BENEFITS UNDER A STATE 18 HEALTH PROGRAM AS PROVIDED UNDER SUBSECTION (B) OF THIS SECTION. 19 IN DETERMINING WHETHER THE 25 EMPLOYEE THRESHOLD IS MET, 20 THE DEPARTMENT SHALL INCLUDE ALL STATE HEALTH PROGRAM BENEFICIARIES 21 EMPLOYED BY: 22 (I) THE EMPLOYER; AND 23 THE EMPLOYER'S SUBSIDIARIES AT ALL LOCATIONS WITHIN (II)24 THE STATE. (3) THE REPORT SHALL INCLUDE: 25 THE NAME AND LOCATION OF EACH EMPLOYER IDENTIFIED IN (I) 27 PARAGRAPH (1) OF THIS SUBSECTION; THE TOTAL NUMBER OF THE NAMED EMPLOYER'S EMPLOYEES 28 (II)29 AND DEPENDENTS WHO ARE ENROLLED IN THE STATE HEALTH PROGRAM; AND (III)THE TOTAL COST TO THE STATE OF PROVIDING HEALTH CARE 31 BENEFITS FOR THE EMPLOYEES AND ENROLLED DEPENDENTS OF EACH NAMED 32 EMPLOYER. 33 THE REPORT MAY NOT INCLUDE THE NAME OF ANY INDIVIDUAL IN
- 34 THE STATE HEALTH PROGRAM AND SHALL BE SUBJECT TO FEDERAL STANDARDS 5 FOR THE PRIVACY OF INDIVIDUALLY IDENTIFIABLE HEALTH INFORMATION.

- 3 SECTION 2. AND BE IT FURTHER ENACTED, That the Department of
- 4 Health and Mental Hygiene shall report to the General Assembly on or before
- 5 December 1, 2006, in accordance with § 2-1246 of the State Government Article, on
- 6 the implementation of this Act.
- 7 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 8 October 1, 2005.
