# Preamble

5 WHEREAS, The Centers for Disease Control and Prevention estimate that 6 61% of Americans are overweight; and

WHEREAS, According to the United States Surgeon General, in the last 20
years the number of overweight children has doubled and the number of overweight
adolescents has tripled; and

10 WHEREAS, The causes of obesity have been linked to an increasing

11 consumption of high-caloric processed foods with high levels of saturated fats and12 sugars combined with a decreasing amount of physical activity; and

WHEREAS, Nonfatal but debilitating effects of obesity include respiratory
difficulty, high cholesterol, high blood pressure, chronic musculoskeletal problems,
skin problems, and infertility; and

16 WHEREAS, Potentially life-threatening effects of obesity include 17 cardiovascular disease including hypertension and stroke, conditions associated with 18 insulin resistance such as Type 2 diabetes mellitus, breast cancer, colon cancer, and

19 gallbladder disease; now, therefore,

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 21 MARYLAND, That the Laws of Maryland read as follows:

22 Article - Education

23 7-401.

24 (a) With the assistance of the county health department, each county board 25 shall provide:

26 (1) Adequate school health services;

27 (2) Instruction in health education, INCLUDING THE IMPORTANCE OF
 28 PHYSICAL ACTIVITY IN MAINTAINING GOOD HEALTH; and

29 (3) A healthful school environment.

31 Each public school shall have a program of physical education that is given in a

32 planned and sequential manner to all students, kindergarten through grade 12, to

33 develop their good health and physical fitness and improve their motor coordination

34 and physical skills.

2 (A) EACH COUNTY BOARD SHALL ESTABLISH A NUTRITION POLICY ON OR
3 BEFORE JANUARY 31, 2006, THAT APPLIES TO ALL FOODS AND BEVERAGES MADE

 <u>SECTION DOES NOT APPLY TO FOODS AND BEVERAGES SOLD FOR FUNDRAISING</u>
 <u>PURPOSES OFF THE SCHOOL GROUNDS.</u>

15 (B) (C) THE NUTRITION POLICY ESTABLISHED UNDER SUBSECTION (A) OF
16 THIS SECTION SHALL BE IMPLEMENTED ON OR BEFORE THE FIRST DAY OF THE
17 2006-2007 SCHOOL YEAR.

18 (C) (D) EACH COUNTY BOARD SHALL:

19(1)PROVIDE THE DEPARTMENT WITH A COPY OF THE NUTRITION20POLICY ESTABLISHED UNDER SUBSECTION (A) OF THIS SECTION; AND

21 (2) REPORT TO THE DEPARTMENT ANY SUBSEQUENT MODIFICATIONS 22 TO THE NUTRITION POLICY.

23 (D) (E) BY AUGUST 1, 2006, ALL VENDING MACHINES IN PUBLIC SCHOOLS
24 SHALL HAVE AND USE A TIMING DEVICE TO AUTOMATICALLY PROHIBIT OR ALLOW
25 ACCESS TO VENDING MACHINES IN ACCORDANCE WITH THE NUTRITION POLICY
26 ESTABLISHED AND IMPLEMENTED UNDER THIS SECTION.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 28 October 1, 2005.
